ORDINANCE No. 103604

An Ordinance authorizing the Purchasing Agent to advertise for and receive proposals for furnishing 10% DDT solution for the Bureau of Insect Control, Mosquito Division, authorizing a contract or contracts therefor, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. That the Purchasing Agent be and he hereby is authorized to advertise for, and receive proposals for, furnishing 10% DDT solutions for the Bureau of Insect Control, Mosquito Division, all in accordance with specifications therefor, filed in the Bureau of Purchases on March 7, 1956, which specifications are hereby adopted.

Section 2. That the Mayor and Auditor be and they hereby are authorized to enter into a contract or contracts with the lowest responsible bidder for furnishing 10% DDT solutions for the Bureau of Insect Control, Mosquito Division, all in accordance with specifications; provided, however, that in case no bids are received which are satisfactory to the Council the Purchasing Agent be and he hereby is authorized to readvertise therefor such number of times as may be necessary to receive satisfactory bids. Payment for the DDT solutions shall be made out of the General Fund, Appropriation Bureau of Insect Control, Mosquito Division, Operation and Maintenance, Code No. 2560.210.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: That it is necessary for the City of Portland to purchase 10% DDT solutions for the Bureau of Insect Control, Mosquito Division, immediately; therefore, an emergency is hereby declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
