Section 1. The Council finds:

1. In accordance with the policies established by the City Council and based on a classification and compensation review, the Bureau of Human Resources is changing the salary grade of the Nonrepresented classification of Parks Turf Maintenance, Irrigation and Equipment Supervisor, effective March 5, 2013.
