

I. RECOMMENDATION. Authorize participation in Federal Communications Commission proceeding on radiofrequency exposure limits and policies

II. BACKGROUND. The Federal Communications Commission (FCC) recently issued a notice of opening an administrative proceeding to consider the agency's regulations on radiofrequency emissions. *Reassessment of Federal Communications Commission Radiofrequency Exposure Limits and Policies* (ET Docket NO. 13-84); *Proposed Changes in the Commission's Rules Regarding Human Exposure to Radiofrequency Electromagnetic Fields* (ET Docket No. 03-137).

In the agency's notice of proposed rulemaking, the FCC observed that periodic review of administrative regulations ensures that the agency's rules keep pace with current knowledge and changing needs, while implementing National Environmental Policy Act (NEPA) requirements for environmental reviews related to health and safety of radiofrequency (RF) emissions from radio transmitters.



According to the FCC, approximately 70% of emergency calls are placed from wireless phones, a percentage that continues to grow and a study conducted by the National Center for Health Statistics noted that between January 2007 to June 2010, the estimated percentage of adults living in wireless-only households in Oregon grew from 18.5% to 30.6%.ing and 39% of Oregon residents are wireless only. Recent industry figures indicate that almost four out of every ten Oregon residents are wireless-only for telecommunications services.

In May 2009, the City Council unanimously approved a request that the federal government undertake efforts to update studies on the potential human health effects of radiofrequency emissions in light of significant increases in the use of wireless telephones and technology studies (Resolution No. 36706). In September 2011, the City Council unanimously adopted a local broadband strategic plan recognizing broadband networks, both wired and wireless, as essential infrastructure fundamental to the future of Portland's citizens and businesses (Resolution No. 36879).
