

RESOLUTION No. 37028

Appoint Roberto Rivera to the Citizen Review Committee advisory board to the Independent Police Review, a division of the City Auditor's Office (Resolution)

WHEREAS, the City Council adopted Ordinance 175652, June 6, 2001, establishing the Independent Police Review (IPR) division and the Citizen Review Committee (CRC);

WHEREAS, a nine-member Citizen Review Committee is responsible for ensuring impartial hearings of appeals, participating in public outreach efforts, and providing an advisory role to the Independent Police Review;

WHEREAS, the committee has one vacancy resulting from the resignation of a CRC member;

WHEREAS, from 53 applicants, seven applicants were recommended by a Selection Committee consisting of three CRC representatives, one member of the community, and the Assistant Program Manager of the Independent Police Review to fill vacancies and additional positions recommended by the Department of Justice settlement agreement;

WHEREAS, the City Auditor nominated this member to City Council;

NOW, THEREFORE, BE IT RESOLVED, that the City Council for the City of Portland, Oregon appoints to the Citizen Review Committee new member Roberto Rivera for a three-year term that begins August 14, 2013 and end August 13, 2016.


