Re: Comprehensive Plan Update - Task 5 Implementation Projects

The update to the City's Comprehensive Plan is being done through five tasks. Task 5: Implementation is the fifth and final task. In general, the projects included in the implementation phase are those necessary to address a Periodic Review mandate, to resolve an issue identified in Task 2: Factual Basis, or require the level of analysis being conducted during Periodic Review.

It should be noted that the Comprehensive Plan will be implemented by projects well beyond those included in Task 5. Because the Comprehensive Plan will guide investments and development over the next 25 years, all planning projects from now until 2035 will implement the new Plan.

Task 5: Implementation Projects

The projects listed below are anticipated to be completed during Task 5. Each project will begin on its own timeline and as staff is available, but all are expected to be completed by mid-2015.

- 1. Mixed-Use Zoning (funded by CET grant)
 - Parking Analysis & Tool Kit for Centers and Corridors (funded by TGM grant)
- 2. Campus Institutions
- 3. Community Involvement Program
- 4. Industrial and Employment Land Supply
 - Amend industrial zoning code to prevent conversion of industrial land
 - Update the Freight Master Plan to support Industrial land intensification
 - Brownfield redevelopment program
 - Golf course transformation to industrial land and watershed health
 - East Portland Dispersed Employment
