

ORDINANCE No.

186372

*Authorize two-year contract with Axiom Event Productions, LLC for \$239,000 for volunteer and course management services through the City of Portland Sunday Parkways program. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Portland Bureau of Transportation (PBOT) Vision calls for a balanced, multi-modal transportation system where residents will have a broad range of safe and convenient transportation options and will frequently walk, bicycle, carpool, or ride public transit as their first choice of transportation.
2. Portland Sunday Parkways promotes healthy active living through a series of free events opening the city's largest public space -- its streets -- to walk, bike, roll, and discover active transportation. Portland Sunday Parkways fosters civic pride, stimulates economic development, and represents the community, business and government investments in Portland's vitality, livability, and diversity.
3. In 2013, Portland Sunday Parkways events drew 87,000 participants and garnered significant media coverage. The City of Portland and its partners plan to implement five annual Sunday Parkways events in 2014 and 2015, which promote walking and bicycling.
4. Axiom Event Productions, LLC. was selected through a competitive bid process to provide volunteer and course management services for five Sunday Parkways in each year for 2014 and 2015 engaging more than 300 volunteers at each event.
5. The Bureau's level of confidence in the cost estimates for this project is optimal.

NOW, THEREFORE, the Council directs:

- a. That the Chief Procurement Officer is authorized to enter into a two-year contract with Axiom Event Productions, LLC., in a form similar to the contract attached as Exhibit A.

Section 2. The Council declares that an emergency exists because critical project meetings are scheduled in early January 2014; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.


