There have been multiple news articles about Right to Dream Too in the various forms of the media, through TV, Radio, Internet and Print. Many people have been engaged in discussion of the efforts by the City and the group to resolve legal difficulties and find another site for Right to Dream Too. A public hearing was held by the City Council on October 3, 2013. Business and community groups in the Pearl District and Old Town Chinatown have participated in meetings and other conversations.

People experiencing houselessness are the main communities of under-represented groups that have participated.

Business leaders in the Pearl District worked with the Mayor's office and PDC to propose the agreement buying Lot 7 and allocating money to REACH and to the City for the purpose of assisting in the relocation of Right to Dream Too. Commissioner Fritz

worked with Right to Dream Too to refine the proposal and reach the agreements in this ordinance.
