

The plaintiff represents himself in this litigation.

He has been shelter less for approximately 7 years and lives outside of Portland, Oregon.

He was a co-founder of Right to Dream.

He creates, and lives in alternative living units. The Silver Bullet was 3' x 3' x 7' wheeled, the White Night, 30" x 30" x 7' and the Kaddi Lack Shack, 2' x 2' x 6' for \$ 49.66.

He has proposed "minimunities" to shelter Portland's apx 10,000 shelter less. Community invites, fenced, self-governing, 25 person max, (ask to see full plan) at no cost to government.

His complaint alleges, among other things, The Portland police and Parks employee conspired to arrest him three times without authority of law. In addition Parks employee Kurt Nelson placed a "notice of illegal campsite" on non parks property and PPB Palmiter directed the sheriff to destroy the plaintiffs home and all its contents. No warrant was issued nor was there a ticket.

The plaintiff entertains the thought that he is the only self-represented shelter less advocate in U.S. Federal court litigation ever.
