TO THE COUNCIL:

The Chief Procurement Officer has advertised and received bids for Bid Number 116296 for the NE/SE 50's Bikeway: NE Thompson to SE Woodstock - Rebid for the Bureau of Transportation, with a project construction estimate of \$714,000. The Bureau of Transportation rated the level of project estimate confidence as Moderate.

Bids were opened on January 16, 2014, and eight (8) bids were received. The low bid of CivilWorks NW, Inc. was deemed responsive to the requirements of the solicitation, and it is recommended that their bid be accepted at the unit price quoted for a total amount of \$705,359.50.

This is a federal-aid transportation project under the Oregon Department of Transportation (ODOT) Federal-Aid Highway Program. Ordinance No. 179568 authorized the Bureau of Transportation (PBOT) to participate in ODOT's Local Public Agency Certification Program for the delivery of federal-aid projects. On June 29, 2011, ODOT's Director informed the Mayor that PBOT had successfully completed the requirements to become fully certified, and City Council accepted ODOT's certification acknowledgement by Ordinance No. 184710. Under ODOT's certification, this project will be reviewed and audited by ODOT for federal-aid project compliance.

Part of the certification is that ODOT shall administer on behalf of the City, ODOT's Disadvantaged Business Enterprise (DBE), Equal Employment Opportunity, and On-The-Job Training (OJT) programs. As such, ODOT establishes the minimum DBE goals for each federal-aid project in compliance with 49 CFR 26. The criteria used in assigning project goals includes, project location, size, duration, dollar value and the availability of DBE firms that can perform identified subcontracting opportunities. This project has a 0% DBE goal. ODOT deemed CivilWorks NW, Inc. to be responsive to the DBE requirement.

CivilWorks NW, Inc. has a current City of Portland Business Tax Registration and their EEO Certification is current through 10/10/15. The company is located in Vancouver, Washington, and is not a State Certified MWESB Contractor.

CivilWorks NW, Inc. is in Full Compliance with the Equal Benefits Program.

Funds are available for this project under Owner Cost Center T00121.C42.
