

Appoint Eugene Rashad, Jerrell Spires and Jose Tornero as Citizen Advisors to Police Internal Investigations Auditing Committee. (Resolution)

WHEREAS, City Code Sections 3.21.030(3) and (4)(b) provide that City Council members of the Police Internal Investigations Auditing Committee appoint Citizen Advisors to the Committee for two-year terms subject to reappointment; and

WHEREAS, City Code Sections 3.21.030(3) and (4)(c) provide for 11 citizens in the advisory group, with six members constituting a quorum; and

WHEREAS, there are six vacancies in the Citizen Advisors' group and the remaining members cannot produce a quorum for their monthly meetings; and

WHEREAS, three appointments are still pending, but three citizens have agreed to serve in the advisory group; and


WHEREAS, it is desirable to establish a full complement of Citizen Advisors by making new appointments promptly;
