

EXHIBIT A

16.20 PUBLIC RIGHT-OF-WAY PARKING

- a. Amend Section 16.20.250 as follows:

16.20.250 Disabled Person/Wheelchair User Zone.

No vehicle may stop or park in a disabled or wheelchair user zone except:

- A. A vehicle transporting a disabled person with an official State-issued disabled person or wheelchair user registration plate, placard, permit or decal; or issued by the Department of Motor Vehicles;
- ~~B. a vehicle with official disabled registration plates while transporting a disabled person; or~~
- ~~C.~~ B. A Tri-Met bus loading/unloading disabled passengers.

- b. Amend Section **16.20.440** as follows:

16.20.440 Meter Fees.

A sign or legend which indicates the interval of time for which parking is permitted and the fee payable for the time interval must be posted on all meters. The parking meter fee must be paid with U.S. coins, ~~or a payment card~~ or any other authorized payment method by the person ~~parking~~ parking within the vehicle, except:

- A. unchanged
 - B. A vehicle with a commercial or delivery permit and a vehicle allowed to use truck loading zones by right may use any metered parking space without meter fee charge on any day between the hours of 8 a.m. and 10:30 a.m. for a maximum of 30 minutes while engaged in loading/unloading merchandise; or
 - C. Any government vehicle, so identified by public registration plates, may park without meter fee for the maximum time limit allowable at any metered parking space.
 - D. and E. unchanged
- c. Add Section **16.20.621** as follows:

16.20.621 Disabled Resident Permit.

A Disabled Resident Permit allows parking in any area designated by the permit. The permit may contain restrictions as deemed necessary by the City Traffic Engineer.

- d. Add Section **16.20.622** as follows:

16.20.622 Disabled Employee Permit.

A Disabled Employee Permit allows parking in any area designated by the permit. The permit may contain restrictions as deemed necessary by the City Traffic Engineer.

- e. Amend Section **16.20.640** as follows:

16.20.640 Disabled Person Permit Placard - Metered Districts

- A. A vehicle with an official State-issued disabled person registration plate, placard, permit or decal, while transporting a disabled person, or a vehicle while transporting a person with an official disabled person placard issued by a state Department of Motor Vehicles, must adhere to all applicable meter regulations, including payment, and may park:

1. In any space designated for a vehicle with a disabled person parking permit for any amount of time placard with a designated time limit of 1 hour, 90 minutes, or 2 hours, a person must pay for the time parked if under the maximum meter time limit, or pay up to the maximum meter time limit allowed and the vehicle may remain parked in that space for up to 3 hours; (subject to on-street storage regulations);
2. In any metered or non-metered space with a designated time limit of 1 hour, 90 minutes, or 2 hours, a person must pay for the time parked if under the maximum meter limit, or pay up to the maximum meter time limit allowed and the vehicle may remain parked in that space for up to 3 hours; 30 minutes or more for any amount of time without fee; or
3. In any metered or non-metered space with a designated time limit less than 1 hour, a person must pay for the time parked if under the meter time limit, or pay up to the maximum meter time limit allowed and the vehicle may remain parked in that space for up to the maximum meter time limit; or of less than 30 minutes for a period of time not to exceed the designated time limit with fee, if applicable, except in any space reserved for special types of vehicles or activities; e.g., truck loading zones, carpool zones, area parking permit areas.
4. In any metered space with a designated time limit of 3 hours or

longer a person must pay for the time parked if under the maximum meter time limit, or pay up to the maximum meter time limit allowed, and the vehicle may remain parked in that space for up to the maximum meter time limit.

~~B. A vehicle with a program placard issued under ORS 811.607 may park as provided under ORS 811.637.~~

B. Use of invalid disabled person parking permit; penalty.

1. A person commits the offense of use of an invalid disabled person parking permit if the person uses a permit that is not a valid permit from another jurisdiction, and that:

- a. Has been previously reported as lost or stolen;
- b. Has been altered;
- c. Was issued to a person who is deceased at the time of the citation;
- d. Has not been issued under ORS 811.602;
- e. Is a photocopy or other reproduction of a permit, regardless of the permit status; or
- f. Is mutilated or illegible.

C. Unlawful use of disabled person parking permit; penalty.

1. A person commits the offense of unlawful use of a disabled person parking permit if the person:

- a. Is not a person with a disability and is not transporting the holder of a disabled person parking permit to or from the parking location; and
- b. Uses a disabled person parking permit described under ORS 811.602 OR 811.606 to exercise any privileges granted under ORS 811.635.

D. Misuse of program placard; penalty.

1. A person commits the offense of misuse of a program placard if the person:

a. Is the driver of a vehicle that is being used as part of a program for the transportation of persons with disabilities; and

b. Uses a program placard described under ORS 811.607 for any purpose other than exercising privileges granted under ORS 811.637.

~~C. Penalties:~~

~~1. Unlawful use: if a person is not a disabled person and is not transporting the holder of a disabled parking permit to or from the parking location and the person uses a disabled parking permit to exercise parking privileges under this Section, that person commits unlawful use under Oregon Revised Statutes.~~

~~2. Misuse: if a driver uses a disabled parking permit for any purpose other than exercising the privileges granted, the driver commits permit misuse under Oregon Revised Statutes.~~

~~D. A vehicle with an official disabled persons permit issued under ORS 811.602, 811.603, 811.604, 811.605, 811.606, 811.607, 811.608, and 811.609, or by the authority of another state, may park as provided under ORS 811.637.~~

~~E. Penalties:~~

~~1. Invalid use of a disabled persons parking permit occurs if:~~

~~a. Driver uses a disabled parking permit that has been previously reported lost or stolen;~~

~~b. Has been altered, was issued to a person who is deceased at the time of the citation;~~

~~c. Has not been issued under ORS 811.602, or by the authority of another state;~~

~~d. Is a photocopy or other reproduction of a permit;~~

~~e. The permit is displayed without the permit number and expiration date clearly displayed~~

~~F. Parking privileges for vehicle parking utilizing Section 16.20.640 will be extended under Senate Bill 716 Section 7 (3). All regulations within this Section will be granted and enforced; this Section will expire on June 30, 2014.~~

f. Add Section 16.20.641 as follows:

16.20.641 Disabled Person Placard – Non-Metered Regulated Parking Zone.

- A.** A vehicle with an official State-issued disabled person registration plate, placard, permit or decal, must adhere to all applicable non-meter regulated parking zone regulations, and may park:
1. In any non-metered regulated parking zone designated for a vehicle with a disabled person parking placard for any amount of time (subject to on-street storage regulations);
 2. In any non-metered regulated parking zone with a designated time limit of 30 minutes or more for any amount of time; or
 3. In any non-metered regulated parking zone with a designated time limit of less than 30 minutes for a period of time not to exceed the designated time limit.
- B.** Use of invalid disabled person parking permit; penalty.
1. A person commits the offense of use of an invalid disabled person parking permit if the person uses a permit that is not a valid permit from another jurisdiction, and that:
 - a. Has been previously reported as lost or stolen;
 - b. Has been altered;
 - c. Was issued to a person who is deceased at the time of the citation;
 - d. Has not been issued under ORS 811.602;
 - e. Is a photocopy or other reproduction of a permit, regardless of the permit status; or
 - f. Is mutilated or illegible.
- C.** Unlawful use of disabled person parking permit; penalty.
1. A person commits the offense of unlawful use of a disabled person parking permit if the person:
 - a. Is not a person with a disability and is not transporting the holder of a disabled parking permit to or from the parking location; and

- b. Uses a disabled parking permit described under ORS 811.602 or 811.606 to exercise any privileges granted under ORS 811.635,

D. Misuse of program placard; penalty.

- 1. A person commits the offense of misuse of a program placard if the person:
 - a. Is the driver of a vehicle that is being used as part of a program for the transportation of persons with disabilities; and
 - b. Uses a program placard described under ORS 811.607 for any purpose other than exercising privileges granted under ORS 811.637.

g. Amend Section **16.20.645** as follows:

16.20.645 Wheelchair User Disabled Person Parking Permit Placard.

- A.** A vehicle with ~~a-an~~ official State-issued “Wheelchair User” ~~plate, placard, permit or decal, issued by a state Department of Motor Vehicles, while transporting a disabled person, or a vehicle while transporting a person with a~~ “Wheelchair User” placard or decal; may park:

1. and 2. (unchanged)

- 3.** In any metered or non-metered space with a designated time limit of less than 30 minutes for a period of time not to exceed the designated time limit with fee, if applicable, ~~, except in any space reserved for special types of vehicles or activities; e.g., truck loading zones, carpool zones, area parking permit areas.~~

4. In an Area Parking Permit Program Zone for any amount of time and without fee.

- B.** A vehicle with ~~an~~ official State-issued “Wheelchair User” ~~program plate, placard, issued under ORS 811.607 may park as provided under ORS 811.637; permit or decal, may not;~~

1. Park in any space reserved for special types of vehicles or activities including, but not limited to, truck loading zones, carpool zones, no parking zones, and reserved zones.

C. Use of invalid disabled person parking permit; penalty.

1. A person commits the offense of use of an invalid disabled person parking permit if the person uses a permit that is not a valid permit from another jurisdiction, and that:

- a. Has been previously reported as lost or stolen;
- b. Has been altered;
- c. Was issued to a person who is deceased at the time of the citation;
- d. Has not been issued under ORS 811.602;
- e. Is a photocopy or other reproduction of a permit, regardless of the permit status; or
- f. Is mutilated or illegible.

D. Unlawful use of disabled person parking permit; penalty.

1. A person commits the offense of unlawful use of a disabled person parking permit if the person:

- a. Is not a person with a disability and is not transporting the holder of a disabled parking permit to or from the parking location; and
- b. Uses a disabled parking permit described under ORS 811.602 or 811.606 to exercise any privileges granted under ORS 811.635,

E. Misuse of program placard; penalty.

1. A person commits the offense of misuse of a program placard if the person:

1. Penalties:

- a. ~~Unlawful use: if a person is not a disabled person and is not~~

~~transporting the holder of a "Wheelchair User" placard or decal to or from the parking location and the person uses a "Wheelchair User" placard or decal to exercise parking privileges under this Section, that person commits unlawful use under Oregon Revised Statutes.~~

- ~~b. Misuse: if a driver uses a "Wheelchair User" placard or decal for any purpose other than exercising the privileges granted, the driver commits permit misuse under Oregon Revised Statutes.~~

~~C. A vehicle with a "Wheelchair User" placard or decal issued under ORS 811.602 through 811.637 or by the authority of another state with current Wheelchair User permit, may park as provided under ORS 811.637.~~

~~1. Penalties:~~

- ~~a. Invalid use of a "Wheelchair User" placard or decal occurs if:~~

- ~~(1) Driver uses a "Wheelchair User" placard or decal that has been previously reported lost or stolen;~~
- ~~(2) Has been altered, was issued to a person who is deceased at the time of the citation;~~
- ~~(3) Has not been issued under ORS 811.602, or by the authority of another state;~~
- ~~(4) Is a photocopy or other reproduction of a permit;~~
- ~~(5) The permit is displayed without the permit number and expiration date clearly displayed~~

EXHIBIT B**16.90 DEFINITIONS**

- a. Add Section **16.90.097** as follows:

16.90.097 Disabled Person Permit/Placard.

Any official State-issued disabled person registration plate, placard, permit or decal, including: Regular, Program, Family, Motorcycle, Golf Cart or any other placard not issued specifically for "Wheelchair Only".

- b. Add Section **16.90.445** as follows:

16.90.445 Wheelchair User Disabled Permit/Placard.

Any official State-issued disabled person registration plate, placard, permit or decal specifically for the use of a wheelchair or similar low-powered, motorized or mechanically propelled vehicle designed specifically for use by a person with a physical disability.
