# a) What impacts are anticipated in the community from this proposed Council item?

This project will construct new public sewers in approximately 27 city blocks and provide 65 properties with direct access to public sanitary sewer service, as part of the Nonconforming Sewer program, instituted by City Council in 2008. Work will include open trench excavation, placement of PVC pipe, manhole work, and necessary paving of trench areas. This work will create some noise, vibration, dust and traffic impacts. This project will provide conforming sewer connections to properties that currently do not have direct and independent connections, improve sewer capacity, and reduce the potential for basement backups. It is possible that bike commuters/riders may be affected at times as there is a bike corridor (NE Going St) is in the area.

Of the 65 properties, 57 are currently considered to have nonconforming sewer connections, some of which have private lines in the right of way and some of which cross other properties without permanent easements. The remaining eight properties in the project currently have conforming sewers which are in need of rehabilitation. BES has reached out to each of the property owners, and has made direct contact with roughly 50 of them. Following completion of this project, each property owner will have a conforming sewer connection.

b) Which community and business groups, under-represented groups, organizations, external government entities, and other interested parties were involved in this effort, and when and how were they involved?

The construction contracting community, including contractors certified with the State of Oregon as minority, women, and emerging small businesses. They became involved when the project advertised for bids on March 24, 2014.

c) How did public involvement shape the outcome of this Council item?

Bids received resulted in the award of the construction contract.

d) Who designed and implemented the public involvement related to this Council item?

Procurement Services advertised the project for bids and held the prebid meeting that was open to the construction contracting community, including contractors certified with the State as minority, women, and emerging small businesses.

- 7. BACKGROUND/ANALYSIS: Ordinance Number 186495 adopted March 19, 2014 authorized a contract and provided for payment for the Inner NE Sanitary Sewer Extension. Approximately 3,100 feet of sanitary sewer pipe is to be constructed in an area of inner NE Portland neighborhoods bounded by NE 6<sup>th</sup> Ave east to NE 17<sup>th</sup> Ave and NE Mason St north to NE Wygant Street. The existing sewers serving these properties are considered non-conforming, and require replacement by direct public sewer services built to current standards.
- 8. <u>FINANCIAL IMPACT:</u> The engineer's estimate for this project was \$1,100,000 and the confidence level was high. Funds are available in the Sewer System Operating Fund, FY 14 and FY 15 Budget, Bureau of Environmental Services, WBS Element E10205.
- RECOMMENDATION/ACTION REQUESTED: Accept Recommendation to award contract to Rio Underground Construction, LLC in the amount of \$1,048,688.00.
- 10. <u>SCOPE OF WORK ON PROJECT:</u> The project includes all labor, materials, tools, equipment, and supervision necessary to construct sanitary sewers

along inner NE Portland neighborhoods bounded by NE  $6^{\rm th}$  Ave east to NE  $17^{\rm th}$  Ave and NE Mason St north to NE Wygant Street
