TO THE COUNCIL:

The Chief Procurement Officer has advertised and received bids for Bid Number 116669 for the East Delta Park Synthetic Fields for Portland Parks & Recreation, with a project construction estimate of \$2,500,000.00.

Bids were opened on June 12, 2014, and Two (2) bids were received. The low bid of Field Turf USA, Inc. was deemed responsive to the requirements of the solicitation, and it is recommended that their bid be accepted at the lump sum amount quoted in their bid for a total estimated amount of \$2,958,338.00.

Portland Parks & Recreation along with Procurement Services, identified Eight (8) Divisions of Work as potential M/W/ESB subcontracting opportunities for this project, resulting in \$1,317,215.00 awarded to subcontractors.

In their bid Field Turf USA, Inc. indicated their intent to self-perform the following divisions of work:
