7. BACKGROUND/ANALYSIS

Joseph McDonnell was driving his 2011 Infiniti sedan northbound on SW 12th Avenue on February 9, 2013, approaching the intersection of SW Clay on a green light. At the same time, a Portland Water Bureau employee driving a Ford F-450 pickup westbound on SW Clay, proceeded through the intersection against the red light. The two vehicles collided in the intersection, with the McDonnell vehicle suffering substantial damage. An eyewitness confirmed the City truck began moving through the intersection while his light was still red. Mr. McDonnell sustained injuries in this crash, and the treatment for these injuries was paid for by his auto insurance. In addition, Mr. McDonnell retained an attorney to represent him in his claim for non-economic (pain and suffering) damages. Risk has negotiated a settlement whereby Safeco Insurance will be paid \$6,454.72 and Mr. McDonnell and his attorney will be paid \$16,000.00, for a total payment of \$22,454.72 to resolve this injury claim.

8. FINANCIAL IMPACT

Approval of the settlement would result in total payments of \$22,454.72 from the liability fund.

9. RECOMMENDATION/ACTION REQUESTED

Approve settlement of Joseph McDonnell bodily injury claim in the total sum of \$22,454.72.
