

ORDINANCE No. 186795

Repeal outdated City Code chapters relating to Civic Stadium and Portland Zoo (Ordinance; repeal Code Chapters 20.24 and 20.28)

The City of Portland ordains:

Section 1: The Council finds:

1. City Code Chapter 20.28, Rental Charges for Civic Stadium, addresses matters relating to rental charges, insurance coverage, restriction on use, and collection of rentals relating to Civic Stadium.
2. The Bureau of Parks and Recreation no longer operates the stadium. The current Stadium Operating Agreement with Peregrine Sports, LLC was approved on July 23, 2009 through Ordinance #183036, and its oversight is in the Office of Management and Finance.
3. The name of Civic Stadium has changed several times in recent years. In 2001 the stadium was renamed to PGE Park, in 2011 to JELD-WEN Field, and in 2014 to Providence Park.
4. On August 29, 2012, through Ordinance No. 185569, outdated City Code Section 20.28.010, Basic Rental Charges, was repealed. The remaining provisions of Chapter 20.28 are also outdated and the chapter should be repealed.
5. City Code Chapter 20.24, Portland Zoo Admission Charges, addresses matters relating to admission fee rates and discounts for the Portland Zoo.
6. In 1977, through Ordinance No. 160035, City Council transferred ownership responsibilities for the Portland Zoo to the Metropolitan Services District (now known as Metro).
7. In 1977, the zoo was renamed the Washington Park Zoo and then Oregon Zoo in 1998.


NOW, THEREFORE, the Council directs:


