SUBJECT:	2035 Comprehensive Plan Errata

Since publishing the Proposed Draft 2035 Comprehensive Plan on July 21, 2014, staff has identified several errata in the proposed plan that we want to bring to your attention prior to your first public hearing on September 23. Errata that are briefly described in this memo and attachment are items that were incorrectly described or identified in the proposed plan. There may be additional errata identified as we move forward, and staff will provide additional memo(s) to the PSC as appropriate to bring these to your attention.

Please note that errata have been narrowly defined as unintended text or incorrect references in the Goals and Policies, or incorrect land uses depicted on the land use map. Examples of the latter include where the map inadvertently proposes open space on privately-owned properties or where a proposed land use change inadvertently splits an ownership.

As you know, a great deal of testimony has already been received through the Map App, emails and letters. Through testimony, the public will continue to raise a number of issues which may prompt staff to reconsider the language of Goals and Policies, proposed land use map changes, and the proposed list of significant projects. These edits are *not* included in this memo, but will instead be presented to the Planning and Sustainability Commission in the form of proposed amendments later in the process.

Any errors within the transportation section of the List of Significant Projects will be addressed by an anticipated PBOT update to that list in October. Staff will provide an overview of that update at the November 4 hearing.

Policy Errata

Policy 3.11 incorrectly refers to "Town Centers". It should simply refer to centers.

Policy 3.12 includes an extra "investment" in the title. The second "investment" can be deleted.

The transit station areas introductory paragraph (preceding Policy 3.43) incorrectly references the streetcar system and the TRAM as "high-capacity transit". These are not part of the regional high-capacity transit system, are more accurately described as local circulators, and their transit stops are not identified on the Urban Design Framework as transit station areas.

Figure 3-2 (Centers) and Figure 3-3 (Corridors): Figure titles and actual figures shown do not match (e.g., the Centers title accompanies the Corridors figure). Correct this mismatch, showing the Centers figure first (to correspond to the policies sequencing).

Policy 4.7 contains an extra comma between "height" and "mass of buildings".

The public art introductory paragraph (preceding Policy 4.46) should say "this policy" rather than "these".

Goal 7. A, Climate. This should read Carbon emissions are reduced to 50% below 1990 levels.

Figure 10-1 incorrectly identifies the CN1 and CO1 zones in relationship to the Neighborhood, Urban Center, and Civic Corridor mixed use designations. CN2 and CO2 are listed as less intense allowed zones. In fact the differences between the 1 and 2 designations for the CN and CO zones are more contextual to the location, and not so much about scale. One is not more intense than the other. The shading should be removed and replaced with dots, as follows:
