

An Ordinance authorizing payment to Multnomah County Cable Regulatory Commission for Multnomah Cable Access and to Portland Cable Access for community access services described in an Intergovernmental Agreement between City of Portland and Multnomah County, authorizing the drawing and delivery of warrants, transferring appropriations within the General Fund Contingency, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The City has entered into an Intergovernmental Agreement with Multnomah County (Ordinance No. 157882; Contract #22673, 10/25/85) to provide a consistent policy for treatment of residential cable television services in annexed areas.
2. The Agreement provides for the City to receive all Rogers Cablesystems Multnomah East (RCME) franchise fee revenues from annexed areas, and pay 40% to Multnomah County Regulatory Commission (MCRC) for payment to Multnomah County Access Corporation (MCA), for access services provided to cable subscribers in annexed areas east of I-205 and north of the Banfield Freeway. In addition, City will pay to PCA 40% of its revenues from RCME areas annexed west of I-205 and south of the Banfield Freeway.
3. The Agreement also provides for the County to receive all RCME franchise fees generated from unincorporated areas west of I-205 and south of the Banfield freeway, and pay to the City 40% of these revenues to be passed on to PCA for access services."
4. An appropriation in the amount of \$13,000 needs to be transferred within the General Fund, based on 85/86 estimates of RCME revenues in annexed areas.

NOW, THEREFORE, the Council directs:

- a. The Mayor and Auditor are authorized to draw and deliver warrants in payment of the services under the agreement in an amount not to exceed \$13,000.
- b. The FY 85/86 City Budget is amended as follows:

Section 2. The Council declares that an emergency exists, in that it is necessary to pay MCRC and PCA per the quarterly payment schedule agreed to among the parties to the agreement; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
