ORDINANCE No. 186877

Update Solid Waste and Recycling Collection Code to clarify the definition of solid waste (Ordinance; amend Code Section 17.102.020)

The City of Portland Ordains:

Section 1. The Council Finds:

1. Portland City Code 17.102.020 defines terms related to solid waste and recycling collection and includes a definition of "solid waste" that refers to ORS 459.005 but excludes listed materials.
2. An update to City Code 17.102.020 is needed to clarify that "grit, screenings and other residues delivered by sewer systems to municipal treatment plants" is excluded from the definition of "solid waste."

NOW THEREFORE, the Council directs:

- a. Portland City Code Subsection 17.102.020 II is amended as follows:

II. "Solid Waste" has the meaning given in ORS 459.005(24)(~~2007~~2013), but does not include the following materials:

1. Sewage Sludge, septic tank and cesspool pumpings or other sludge; and grit, screenings and other residues delivered by sewer systems to municipal treatment plants.
2. Discarded or abandoned vehicles;



