Any pertinent background information?) The Department of Homeland Security provides financial assistance to selected urban areas through their Urban Areas Security Initiative (UASI) Grant Program. The City of Portland, in conjunction with regional partners (TriMet, Port of Portland, Multnomah, Clackamas, Washington and Columbia Counties of Oregon and Clark County, Washington) applied for financial assistance to address the unique equipment, training, planning, exercise and operational needs of the large urban area. It is important because the funds will be used to enhance the region's emergency preparedness through planning, training and equipping of emergency responders. There is nothing controversial about this Ordinance.

Purpose of proposed legislation and background information:

- The purpose of this legislation is to accept and appropriate the FY 2014/2015 Urban Areas Security Initiative (UASI) Grant from the Department of Homeland Security through the Oregon Military Department Office of Emergency Management. This is important because the grant funds will be used to help strengthen the region's (Port of Portland, Multnomah, Clackamas, Washington and Columbia Counties of Oregon and Clark County, Washington) capabilities in preparing and responding to emergencies.
- The City of Portland has been a recipient of UASI funding since FY 2003; with the exception of FY 2013.

Financial and budgetary impacts:

- Long-term financial impacts. The grant does not require matching funds, therefore, there will be no financial obligation on the part of the City of Portland.
- **Budget impacts**. This grant will increase the FY 2014 budget by \$846,598, but will also have off-setting expenses of the same amount.
- **Change in cost.** The legislation is not authorizing additional spending on the part of the City of Portland.
- Change in current and future revenues and expenses, including dollar amounts and funding sources. This legislation in the form of the UASI FY 2014 grant, will increase the FY 2014 budget by \$846,598; but will also have off-setting expenses of the same amount.
- If the expense is a "project estimate", identify the level of confidence about the accuracy of the estimate. We are extremely confident that the project expenses will not exceed the amount of the grant; as the grantor will not allow expenses greater than the amount awarded.
- Current and future staffing levels does the legislation create, eliminate or re-classify positions now or in the future? How much staff time will this legislation require (even if covered by an existing position)? What are the demographic impacts of changes in staffing? The legislation does not create, eliminate or re-classify any positions now or in the future. About 75% of the current Sr. Management Analyst time will be spent administering, monitoring and performing oversight as with past UASI funding. In addition, about 100% of PBEM's Grant Program Coordinator's time will be spent administering, assisting with compliance, procurement, and monitoring grant activities. There are no demographic impacts or changes in staffing.
- Financial agreements indicate if the legislation results in a new financial obligation or benefit (or modifies an existing one) including interagency agreements, intergovernmental agreements, memoranda of understanding, grants, contracts or contract amendments. This legislation will be a

benefit to the City of Portland in the form of a grant. It will result in new intergovernmental agreements between the City of Portland and the grant sub-recipients (Port of Portland, Multnomah, Clackamas, Washington and Columbia Counties of Oregon and Clark County, Washington).
