BE IT RESOLVED that the following temporary rule concerning the adjustments of benefits authorized under Section 5-312 of the Plan be and hereby is adopted by the Board of Trustees of the Fire and Police Disability and Retirement Fund.

> Annual Cost of Living Benefit Adjustments. Benefits payable under Section 5-304 (Retirement Benefits) and Section 5-305 (Termination Benefits) of the Fire and Police Disability, Retirement and Death Benefit Plan will be adjusted on August 1 of each year to reflect changes in the cost of living. However, the percentage rate of change shall not exceed the percentage rate applied to retirement benefits payable to police officers and fire fighters covered under the Public Employes' Retirement System of the State of Oregon. A Member's benefits will be adjusted on August 1 of any given year only if the member separates from service before July 15 of that year.
