

Resolution No. 314


WHEREAS, Calvin E. Gantenbein, Jr., a former member of the Bureau of Police, applied for service-connected disability benefits (including medical benefits) from the Fire and Police Disability and Retirement Fund (Fund) alleging that he had sustained an injury ((R) C7-T1 spondylosis and herniated disk) which was attributable to work-related events and circumstances occurring on or about March 23, 1998; and

WHEREAS, there is a bona fide dispute as to whether Calvin E. Gantenbein, Jr.'s claim is compensable as a service-connected disability; and

WHEREAS, the matter has now been compromised and settled.

NOW, THEREFORE BE IT RESOLVED by the Board of Trustees of the Fire and Police Disability and Retirement Fund that the Stipulation and Order of Dismissal attached hereto as Exhibit "A" and dismissing the above described application for service-connected disability benefits be and the same hereby is adopted as the Order of the Board of Trustees of the Fire and Police Disability and Retirement Fund.
