Safe Routes to School study, 2006 (http://swni.org/CMS-Uploads/BNASR2SERSM2.pdf)documents many hazards for pedestrians and cyclists, including high vehicle speed, congestion, visibility issues, unsafe crossings and Tri-Met stops; lack of pedestrian and bike paths. A study by residents analyzed why Hamilton is key to traveling across and in Bridlemile. (see http://swni.org/bridlemile/949). A project focused on mitigating or eliminating the documented hazards is necessary. That need not require the full widening of Hamilton, or addition of sidewalks on both sides. Less expensive solutions could be designed to effectively address the

Having recently moved to this neighborhood from one with a 98 walkability score, it is appallingly apparent that there is a need for SAFER and more ACCESSIBLE routes for every\"body\" and mode. As owners of a corner property at 9th and TF Rd who require use of a wheel chair, we cannot navigate our own property line because the route along TF Rd

has no sidewalk and is too unsafe to use even the gravel shoulder of the right-of-way! An improved route provides an opportunity to resolve some STORMWATER issues. We have observed on numerous occasions a rushing stream of water coursing south, down 9th Ave., turn onto TF Rd and pool at an often clogged storm drain. The upzoning of this area from R2 to R2.5 is commendable as a means of better protecting the great collection of historic homes in this area, which are only partially protected by the Historic Conservation District designation. However you missed the similarly zoned (R2) blocks immediately to the east in the Irvington Historic District. The blocks on the east side of 7th Avenue are subject to the more stringent requirements of the Historic District's design review, but are exposed to improvident development by inappropriate zoning. The logic that applies to the block in Eliot rezoned to R2.5 equally would apply to the comparable R2 blocks across the street in the Irvington Historic District. I note that except for possible new Multi-Use zoning changes along NE Broadway, no zoning changes are proposed for the Irvington neighborhood and its Historic District. This is a grave oversight and will simply perpetuate the long-standing potential conflict between historic resource review standards and the zoning. As you may know, City Code explicitly gives precedence to historic resource review standards over zoning when they conflict. Leaving the conflicts in place forces those conflicts to be repeatedly tested in case after case. Why haven't some of

Re McMansions: There isn't an appropriate spot to comment on the problem of McMansions on this plan. However, I think I speak for many of my neighbors when I say that one of the

two biggest threats to our neighborhood character (and safety) is the demolition of modest, historic homes by developers building McMansions. Most of the people I know in this neighborhood value economic diversity--a neighborhood where a young family or an elderly couple can also afford a small home alongside larger family homes. Sadly, however, any small house that becomes available is snatched up by a developer who knocks it down. Secondly, when small, older homes are demolished, enormous clouds of lead dust are released

upon the neighborhood for blocks in every direction. I was unexpectedly caught in such a cloud one day and noticed that it surrounded several houses where young children live. Thirdly,

these large houses impact the quality of life for neighbors, robbing them of light, views and privacy previously enjoyed. Fourth, dramatically increasing home sizes does not serve the goal of sustainability--heating and maintaining these houses will require more resources--as family size decreases, home size should not so dramatically increase. Lastly, many of these houses are eyesores, completely out of character in design and scale, on the streets where they are built. Proposed Solution: Please amend the zoning in Sellwood and Westmoreland so that demolition of an existing home is forbidden, unless it is uninhabitable. Further, please limit the percent that a home's size may be increased, capped at 30% or 40% larger, for instance and increase setback requirements in the side lots to give neighbors breathing room. A good model to look at is Palo Alto, California. I don't remember the details, but I do remember that the character of the historic neighborhood abutting Stanford University was maintained by limiting remodeling efforts to the footprint of the original plus a limited percent increase in square footage. The result is a neighborhood of lovingly restored historic houses with tasteful additions and beautiful gardens.
