Appoint Julie Ramos, Kiosha Ford, Angelo Turner, Julie Falk, Vanessa Yarie, and Kristin Malone to the Citizen Review Committee advisory board to the Independent Police Review, a division of the City Auditor's Office. (Resolution)

WHEREAS, the City Council adopted Ordinance 175652, June 6, 2001, establishing the Independent Police Review and the Citizen Review Committee;

WHEREAS, an eleven-member Citizen Review Committee is responsible for ensuring impartial hearings of appeals, participating in public outreach efforts, and providing an advisory role to the Independent Police Review;

WHEREAS, the committee has six vacancies resulting from the completion of terms by four committee members and the resignation of two members;

WHEREAS, from 30 applicants, six applicants were recommended by a Selection Committee consisting of three Citizen Review Committee representatives, two members of the community, and the Assistant Program Manager of the Independent Police Review;

WHEREAS, the City Auditor nominated the six recommended members to City Council

NOW, THEREFORE, BE IT RESOLVED, that the City Council for the City of Portland, Oregon appoints to the Citizen Review Committee new members Julie Ramos, Kiosha Ford, Angelo Turner, Julie Falk, Vanessa Yarie, and Kristin Malone for three-year terms that begin February 11, 2015 and end February 10, 2018.



