ORDINANCE NO. 149822

An Ordinance vacating certain portions of SW 13th Avenue, SW 14th Avenue, SW 15th Avenue, SW 16th Avenue, SW Meade Street, SW Hooker Street, SW Porter Street, SW Woods Street, SW Grover Street, SW Gibbs Street, SW Whitaker Street and SW Curry Street, all in the area commonly referred to as Marquam Nature Park, under certain conditions.

The City of Portland ordains:

Section 1. The Council finds:

- Resolution No. 32639 adopted by the Council March 26, 1980, initiated proceedings for the vacation of portions of several streets within the area commonly referred to as Marquam Nature Park.
- The vacation was requested by the Portland Bureau of Parks and Recreation to preserve the area for park purposes.
- The vacation is recommended by the Commissioner of Public Works under certain conditions set forth in the directive action below.
- In accordance with O.R.S. 271.100, the Council fixed a time and place for public hearing before the Council; the Auditor published notice thereof; and posted notice in the areas proposed to be vacated.
- 5. Other procedural requirements of O.R.S. 271 have been complied with and the Council having held a public hearing finds no objections were made or filed hereto and it is in the public interest that said streets be vacated.

NOW, THEREFORE, the Council directs:

a. That portion of SW 13th Avenue lying between the north line of SW Porter Street and its terminus at the easterly extension of the north line of Block 111, Portland City Homestead, AND ALSO

That portion of SW 14th Avenue lying between a line drawn 50 feet north of and parallel with the north line of SW Woods Street and its terminus at the westerly extension of the north line of Block 111, Portland City Homestead, AND ALSO

That portion of SW 15th Avenue lying between the north line of SW Whitaker Street and its terminus at the easterly extension of the north line of Block 123, Portland City Homestead, AND ALSO

Those portions of SW 16th Avenue lying between the north line of SW Curry Street and its terminus at the westerly extension of the north line of Block 123, Portland City Homestead, AND ALSO



That portion of SW Meade Street lying between the east line of SW 15th Avenue and its terminus at the northerly extension of the east line of Block 118, Portland City Homestead, AND ALSO

That portion of SW Hooker Street lying between the west line of SW 16th Avenue and its terminus at the southerly extension of the east line of Block 118, Portland City Homestead, AND ALSO

That portion of SW Porter Street lying between the west line of SW 13th Avenue and its terminus at the northerly extension of the west line of Block 97, Portland City Homestead, AND ALSO

Those portions of SW Woods Street, SW Grover Street and SW Gibbs Street lying between the west line of SW 14th Avenue and their terminus at the southerly extension of the west lines of Blocks 97, 86 and 75, Portland City Homestead, AND ALSO

That portion of SW Whitaker Street lying between the west line of SW 15th Avenue and its terminus at the northerly extension of the west line of Block 53, Portland City Homestead, AND ALSO

That portion of SW Curry Street lying between the west line of SW 16th Avenue and its terminus at the southerly extension of the west line of Block 53, Portland City Homestead, are hereby vacated.


b. The vacation of the above described street areas is granted subject to the following conditions and restrictions:


Nothing herein contained shall cause or require the removal or abandonment of any sewer, water or gas main, conduit of any kind, wire, pole or thing used, or intended to be used, for any public service, (including but not limited to existing sewers and water mains), and the right hereby is reserved for the owner of any such utility or thing to maintain, continue, repair, reconstruct, renew, replace, rebuild, and/or enlarge any and all such things; that no building or structure of any kind shall be built or erected within a distance of ten feet from the centerline of any such utility, except with the prior written consent of the City Engineer and the owner of the utility and that any and all contemplated building plans in said vacated area shall be submitted for approval to the City Engineer and to the Director of the Bureau of Buildings, to the end that such construction may be so adjusted with reference to all public utilities in said area as to cause a minimum of danger or inconvenience to the public and to the owner of such utility and to protect and preserve the same as presently constructed or hereinafter reconstructed, renewed, replaced and/or enlarged.

ORDINANCE No.

Section 2. The Auditor shall file with the recorder, the assessor and the surveyor of the County in which said property is located, a certified copy of this ordinance and any map, plat or other record which may be required by law.
