#### Purpose of proposed legislation and background information:

The purpose of this funding is to support the construction of the Urban Grange, which will provide classroom space and office space to support Friends of Zenger Farm's mission to promote and educate about sustainable food systems, environmental stewardship, community development and access to good food for all.

- Friends of Zenger Farm has secured most of the funding they need to construct the Urban Grange, a grant by City of Portland will help them fill a funding gap in their capital campaign.
- For the residents of East Portland, the Urban Grange will increase their ability to access Friends of Zenger Farm programs like "Healthy Eating on a Budget".
- The Urban Grange will also provide more classroom space so the organization can reach more youth through the school and summer programs.
- The Urban Grange is being built consistent with City of Portland Green Building and Ecoroof policies. The completed project will demonstrate sustainable development practices including energy efficiency and sustainable stormwater management.

#### Financial and budgetary impacts:

- This ordinance will allocate \$100,000 in one-time grant funds from a FY 2014/15 Special Appropriations request from General Fund revenues to the nonprofit Friends of Zenger Farm.
- This ordinance will not generate or reduce future revenue.

#### Community impacts and community involvement:

The decision to provide this special allocation was made as part of the City Council's budget for fiscal year 2014/2015, which is developed through a public process.

- This is a one-time grant for specific activities that will be completed this Fiscal Year.
- The ordinance is a consent item. No testimony is anticipated.

This grant will benefit youth, culturally-diverse, low-income and other under-served populations.

- The special allocation will help Friends of Zenger Farm serve more youth and residents of East Portland, including Lents, Powellhurst Gilbert, and Pleasant Valley neighborhoods.
- Schools in the area are some of Portland's most culturally diverse, with a high proportion of students on free and reduced-price lunch.
- Census data shows that residents in this part of East Portland have a lower overall educational attainment rate lower than median household incomes compared to citywide averages.

#### Background and Mission:

The City of Portland purchased Zenger Farm in 1994 to preserve wetlands, open space and provide opportunities to manage flooding and stormwater. Incorporated in 1999, Friends of Zenger Farm (FZF) was created to manage a six-acre organic farming operation in Southeast Portland and to transform it into a community learning center for environmental stewardship, sustainable food systems, and local economic development.

Zenger Farm is leased to FGF under a 50-year, renewable agreement with Bureau of Environmental Services. Annual visits to Zenger Farm have grown from the early days when a few hundred Portland students a year made field trips to over 8,000 kids and adults annually now participating in a mix of programs and workshops.

Every year thousands of kids and families visit the farm to learn about and participate in farm to fork connections and where good, healthy food comes from through field trips, camps, and workshops

The Urban Grange will be a hub for healthy food and community connection, and include:

- 1. A multi-use classroom that will allow Zenger Farm to increase the number of students participating in educational programs each year from 7,500 to 13,000.
- 2. A commercial kitchen that will help 20 low-income entrepreneurs launch emerging food businesses, enabling cooking workshops for groups of 20 and increase annual participation in our Healthy Eating on a Budget classes from 1,000 to 2,000 families.
- 3. Office space for 20 people, enabling staff to meet the growing demand for programming and improve program delivery. We will also rent space to food-system based non-profits, creating a new revenue stream and fostering broad partnerships and connections among like-minded mission-driven groups.

Funds are being requested to leverage the \$2 million already raised to build the Urban Grange. The construction of the Urban Grange will facilitate a substantial increase in visitors per year to Zenger Farm.
