RICAP Projects

- Amendments:
 - address a variety of topics and geographies
 - limited in scope (minor policy/technical)
 - not part of new Comp Plan Implementation
- Packaged for efficiency
- On an annual cycle



RICAP Selection Criteria

- 1. Variety of stakeholders
- 2. Geographic applicability
- 3. Degree of impact
- 4. Regulatory Improvement





RICAP 8–Proposed Workplan

37 items total:

- 12 minor policy items
 - 6 Land Division Items
 - 3 Property Line/Lot Confirmation Items
 - 1 Radio Frequency Item
 - 2 Miscellaneous (signs and loading)
- 25 technical and clarification items
 - 10 related to the Tree Code
 - 15 Miscellaneous Zoning Code



RICAP 8 — Minor Policy Land Division Bundle - 6 Items



- 1. Density calculation multidwelling ROW dedication
- 2. Density calculation multidwelling land constraints
- 3. Streams, springs, seeps and drainageways
- 4. Density calculation common greens and pedestrian connections
- 5. Lot consolidation process
- 6. Plat Vacation process

RICAP 8 – Technical/Clarification Items

- Do not alter adopted policy
- Do not require significant resources or specialized outreach
- Added to RICAP automatically
- 10 items related to Title 11, Trees
- 15 items related to Title 33, Zoning



RICAP 8–Next Steps

- Spring Fall 2015: Staff analysis of issues and development of code amendment proposals
- Winter 2016: Public outreach and discussion
- Spring 2016: PSC hearing on code amendments
- June 2016: City Council hearing on code amendments
