I am writing to request to be included in one of the five slots, reserved by Ms. Kate Howser, at the City Council Meeting to be held on April 22, 2015. I wish to speak about the current and potential future proposals and permits to be issued and/or filed with respect to development of property on SE 50th Ave, between Hawthorne Ave. and Division St., in Southeast Portland. I am a member of the group that is opposed to the proposed development of an 84 Unit apartment complex by SK Hoff on the block of SE 50th Ave. between Mill St. and Lincoln St. I believe that the current Portland Comprehensive Plan, and the zoning regulations promulgated thereunder more than 20 years ago, are invalid as applied to the SE quadrant of the City of Portland, and this neighborhood in particular, and moreover, are inconsistent with the City of Portland's stated goals with respect to sustainable development and maintenance of neighborhood character.

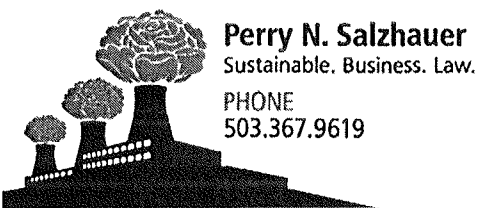


