Subject: Accept Report on Civil Service Board Activities for Calendar Year 2014 (Report)

City Charter Section 4-402(6) – Duties of the Board - states: "The Board shall meet at least quarterly and shall report annually to City Council on its activities for the prior year." Human Resources Administrative Rule 3.15 - Civil Service Board - states: "It shall also be the duty of the Board to submit reports as requested by City Council regarding the activities of the Board as they pertain to the application of merit principles in City personnel administration."

Appeals to the Civil Service Board must fall into one of three categories: appeals from suspensions, demotions and discharges ("disciplinary appeals"), appeals from classification actions ("classification appeals"), and appeals from examinations ("exam appeals").

During calendar year 2014, the Board received four appeals. Of these appeals, two were disciplinary, two were exam appeals, and there were no classification appeals.
