This is a very ironic situation. As you can see, I received a letter from Mayor Charlie Hales saying, "I have read and reviewed the letters that were sent in support of recognizing Indigenous People's Day in place of Columbus Day." I followed up by contacting the office of the mayor, and was instructed by Cindy Reyes on how to write a resolution, which I did. She responded by saying, "Our office has read and reviewed the resolution that you proposed to change Columbus Day to Indigenous People's Day. Because the request did not come from Portland constituents, our office will not move forward with the resolution." She didn't say that the office would not move forward on the resolution because the City of Portland actually doesn't observe Columbus Day at all. The resolution ends with the sentence: Now, therefore be it resolved that the City of Portland will no longer observe Columbus Day, but rather celebrate Indigenous People's Day.

If the City of Portland came out publicly and said that it currently doesn't celebrate or even observe Columbus Day (and hasn't in years) and it wants to add Indigenous People's Day to its official calendar, that would be of great value. I can just imagine the nightmare of trying to find funding for another paid holiday. However, I see that Portland currently has two paid holidays devoted to Thanksgiving. Perhaps the Friday after Thanksgiving could simply be named Indigenous People's Day? There is great poetic justice in this, as Thanksgiving is for many Native Americans a celebration of the beginning of the end for their people.
