### Details:

Received information that the High School Collective had been granted a permit to hold a Rock Festival in Washington Park On Sunday, July 18, 1971

Contacted Pat BELL of the Park Bureau and she stated that the High School Collective was issued a permit on 7-8-71 for a music festival to be held July 18 at the elephant house kitchen area of Washington Park. The concert was to last for from 5:PM to 10:PM and was to be free rock music. There was to be no merchandise sold. The Collective will serve food and beverages for free. They estimate about 500 people will attend.

The person applying for the permit was PAUL LEITSCHUH, 4005 NE Stanton, phone number 281-6692. He is over 21 years of age and has a sister Carol who is a volunteer worker, working for the Park Bureau Recreation Dept. He was asked if he will be in charge, and he stated "No" that he would not be in attendance, but DAVID LINN, of 536 SE 17th Ave., would be in charge.

Checked files on PAUL LEITSCHUH and could find nothing. Checked files on DAVID LINN and find he was 17 years in September 1970.

LINN has been very active in the High School Collective along with his father DANIEL LINN, Jr.

We have received information from reliable informants that the High School Collective has been the one behind the issue of the Park curfew in Washington Park and were active in arousing interest to defy the park curfew. They are also advocating harrassing the police officers when they attempted to enforce the curfew.

We believe the High School Collective will use the music festival to gather people to the park in the hopes they will stay past curfew and create problems for the police.

We will attempt to contact sources to see if this is the intention of the High School Collective and report.

As this address is the headquarters for the Portland Revolutionary Youth movement (PRYM) all vehicles associated with this address, attempts are made to identify the registered owners.

# Teen-Agers Push For School Rights

More than 50 Portland high school students attended the opening session Saturday morning of a student rights conference which had been called to plan activities to persuade school board officials to recognize student political organizations as legitimate school clubs.

Those attending the conference at Portland State University stressed the theme that they feel high school students are not guaranteed the constitutional rights of assembly and free speech.

**THE CONFERENCE** was called by the Student Mobilization Committee to End the War in Southeast Asia (SMC), which was turned down Feb. 8 by the Portland School Board when students asked permission to meet at high schools.

"The most important right we are seeking is the right of any student to form any organization as a club on campus," John Linder, Lincoln High School junior, told the group.

Students later in the day debated motions on resolutions they want to present to the school board.

**KEYNOTE** speaker at the conference, Sara Smith, a Wilson High junior, condemned what she called the "students-are-dumb philosophy" of the Portland School Board and administrators.

"Apparently the board feels students have to be discouraged from learning political processes," she said. Because School Board decisions have emphasized nonpartisan stands when confronted with the issue of partisan clubs, Miss Smith said, "The school becomes an indoctrination process."

"The administration loves everyone, as long as they play the game," she said. "Well, some students have broken the mold, and refuse to play the game."

**"STUDENTS ARE** no longer dumb, they are citizens."

One student attending the conference suggested "you have to play their game a little bit," and said students who want to start clubs should stress the educational value of organizations.

An Adams High student said the issue of political clubs has become a class project in political science. Duncan Smith, an Adams junior, said the rights of 18-year-olds to vote should be considered, since many of next year's high school seniors will be able to vote in the 1972 presidential election.

**"HOW CAN** the school board say those students can't express political beliefs if they can vote?" he asked.

Linder told students he

would like to see groups of all political beliefs — ecology groups, pro-war, anti-war — recognized as valid school clubs.

This recognition would allow club meetings on school property, an issue the school board has opposed since its members say they believe a school should be nonpartisan. The board has also expressed concern that political clubs would restrict their membership to students whose beliefs fit with club philosophy.

"There already are special-interest clubs with membership restrictions," Miss Smith said in her brief address. She cited clubs limited to lettermen, and said science clubs and religious clubs imply special interests.

## Students Outline 'Rights'

Establishment of the Portland High School Rights Coalition, resolutions pertaining to the rights of high school students and promises of further action in the near future were the result of a "rights conference" held by high school students Saturday at Portland State University.

On the premise that high school students are entitled to the rights granted Americans under the U.S. Constitution and Bill of Rights, the 65 high school students registered at the meeting formed the coalition which will be composed of representatives of organizations which include high-school-age members.

**THE COALITION** announced it will ask the Portland School Board for a public hearing to present its proposals.

John Linder, 15, a student at Lincoln High School and spokesman for the coalition, announced that another meeting of the group is scheduled Saturday, April 3, at a location to be decided.

Resolutions adopted by the coalition state that students have the right to recognition of any political organization as an official club in their schools and that such organizations have the right to meet and publicize events and activities as other clubs do.

**ALSO, THE** coalition maintained in its resolutions, students have the right to choose what school they want to attend, within the capacity of the schools; that girls should be allowed to attend Benson Polytechnic High School; that students have the right to distribute and post in schools any literature, and that students have the right to be informed at the beginning of each school year, in written form and in an orientation program, of their rights under the law.

The coalition asserted it opposes the School Board's rule that no school may have more than 25 per cent of any racial minority in attendance. It also approved resolutions stating there should be no nonstudent censorship of student publications and asking removal from the schools of all undercover police agents.

## 'Coalition' Reveals Demands

A seven-point list of demands was fired at Portland school authorities Wednesday by leaders of the Portland High School Rights Coalition.

The high school students demanded the right to hold political meetings, distribute and post literature, including calls for demonstrations or student strikes; to oust undercover narcotics agents from high schools and to publish student newspapers and magazines without censorship but with teachers' advice.

**THEY ALSO** said students should have the right to attend any high school they like. They called for repeal of the Portland school rule whereby no more than a fourth of the students at any high school may be black. They also demanded that girls be allowed to go to Benson High School, where they now may attend only summer classes.

The spokesmen, at a press conference held at the Old Church, also said students should have the right to meet in schools to "organize for the jobs they need. In answer to a question, Judy Davidson, senior at Adams High School, said the students would "put pressure on the State Senate for more job opportunities and training."

"**STUDENTS** are not likely to get the jobs they need until they organize," she said.

In answer to another question, Robert Anderson, junior at Grant High School, expressed belief that students would vote to allow undercover narcotics agents at schools.

"We think these rights can be won by a mass high school rights movement," he declared. "We hope to reach our goals through peaceful channels."

**ASKED** what they would do if they failed "through channels," he answered, "We'll cross that bridge when we come to it."

The spokesmen also demanded that students be told of their legal rights in writing at the beginning of the school year.

"Students have the right to exercise all rights listed in the U.S. Constitution, the Bill of Rights and all the other amendments as interpreted by the U.S. Supreme Court," Anderson declared.

Many of the same students asked the Portland School Board earlier this year for the right to carry on political activity in school buildings and were denied. Organization of the student coalition followed.
