An Ordinance adopting the report of the City Engineer in the matter of the proposed opening, widening, laying out and establishing of Dawson Street, from the east line Fiske Street to the south line of Columbia Park.

The City of Portland does ordain as follows:

Section 1: WHEREAS, The Council of the City of Portland deeming it expedient to open, widen, lay out and establish Dawson Street from the east line of Fiske Street to the southerly line of Columbia Park. The southerly line of the proposed street to be 80 feet southerly from and parallel with the northerly line of Dawson Street, as laid out in Norwood and the northerly line an extension in its present course of the north line of Dawson Street as laid out in Norwood, did, on the sixth day of April, 1904, direct the City Engineer to survey the same, and to mark the boundaries thereof, and to make a plat of such survey, and a written report containing a * 11 and perfect descrip tion of such proposed Street and the boundaries thereof and of the portion of each lot, tract or part of either, to be appropriated for such street, and the City Engineer having made such survey, plat and report and filed such plat and report in the office of the Auditor on the ninth day of April 1904 and the said plat and report being satisfactory to the Council, is now hereby adopted, of which report of Wm. C. Elliott, City Engineer the following os a copy, to-wit:

CITY ENGINEER'S OFFICE, PORTLAND, ORE., APRIL 9, 1904.

TO THE HONORABLE MAYOR ALD COUNCIL OF THE CITY OF PORTLAND:

Gentlemen:-

In pursuance of a resolution adopted by your Honorable Body at your meeting of April 6th, 1904, directing me to survey and mark the boundaries of the proposed opening, widening, laying out and establishing of Dawson Street in the City of Portland, from the east line of Fiske Street to the south line of Columbia Park, I have surveyed and marked the boundaries of the proposed Dawson Street, and herein submit my report together with a plat of said survey.

The proposed opening, widening, laying out and establishing of Dawson Street is more particularly bounded and described as follows:

Beginning at a point in the southwesterly corner of Block 107 Norwood, running thence southeasterly along the south line of blocks 107 and 112 Norwood, and an extension southeasterly there of, to an intersection with the westerly line of the County Road running easterly and westerly along the south boundary of Columbia Park; thence westerly along the north line of the County Road to a point 80 feet distant from and at right measurement to the northerly line of the proposed Dawson Street as above described; thence northwesterly on a line 80 feet distant from and parallel with the northerly line of the proposed Dawson Street as above described, to a point in the easterly line of Fiske Street; thence northeasterly 80 feet to the place of beginning.

The proposed opening, widening, laying out and establishing of Dawson Street will include and necessitate the appropriation to public use the following described parcels or tract of land:

All that part of lot 20, block 113 University Park, lying between the southerly line of block 113 University Park, and the northerly line of the proposed Dawson Street, containing 117 square feet.

Also all that part of lot 21, block 113 University Park, lying between the southerly line of Block 113 University Park and the northerly line of the proposed Dawson Street, containing 1702 square feet.

Also all that part of lot 28, block 124, University Park lying between the southerly line of block 124 University Park, and the northerly line of the proposed Dawson Street, containing 1124 square feet. Also all that part of lot 27, block 124 University Park, lying between the southerly line of block 124 University Park, and the northerly line of the proposed Dawson Street, containing 1124 square feet.

Also all that part of lot 30, block 125 University Park, lying between the southerly line of block 125 University Park, and the northerly line of the proposed Dawson Street, containing 766 square feet.

Also all that parcel or tract of land lying between the easterly line of University Park and the southerly extension thereof and the northerly line of the County Road, running easterly 'and westerly along the south boundary of Columbia Park and between the northerly and southerly lines of the proposed Dawson Street, containing 31192 square feet.

Also all that part of lot 36, block 4 Tiffts Subdivision, lying between the northerly line of Block 4 Tiffts Subdivision and the southerly line of the proposed Dawson Street, containing 1425 square feet.

Also all that part of lot 1, block 4 Tiffts Subdivision, lying between the northerly line of block 4 Tiffts Subdivision and the southerly line of the proposed Dawson Strest, containing 1425 square feet.

Also all that part of lot 8, block 3 Smithson Land Company's Addition, lying between the northerly line of block 3 and the southerly line of the proposed Dawson Street, jontaining 375 squar feet.

Also all that part of lot 7, block 3 Smithson Land Company's Addition, lying between the northerly line of block 3 and the southerly line of the proposed Dawson Street, containing 375 square feet.

Also all that part of lot 6, block 3 Smithson Land Company's Addition, lying between the northerly line of block 3 and the southerly line of the proposed Dawson Street, containing 375 square feet.

Also all that part of lot 5, block 3, Smithson Land Company's Addition, lying between the northerly line of Block 3 and the southerly line of the proposed Dawson Street, containing 375 square feet.

Also all that part of lot 4, block 3 Smithson Land Company's Addition, lying between the northerly line of block 3 and the southerly line of the proposed Dawson Street, containing 375 square feet.

Also all that part of lot 3, block 3 Smithson Land Company's Addition, lying between the northerly line of block 3 and the southerly line of the proposed Dawson Street, containing 375 square feet.

Also all that part of lot 2, block 3, Smithson Land Company's Addition, lying between the northerly line of block 3 and the southerly line of the proposed Dawson Street, containing 375 square feet.

Also all that part of lot 1, block 3 Smithson Land Company's Addition, lying between the northerly line of Block 3 and the southerly line of the proposed Dawson Street, containing 375 square feet.

Also all that part of lot 8, block 2 Smithson Land Company's Addition, lying between the northerly line of block 2 of Sm.thson Land Company's Addition and the southerly line of the proposed Dawson Street, containing 375 square feet.

Also all that part of lot 7, block 2 Smithson Land Company's Addition, lying between the northerly line of block 2 of Smithson Land Company's Addition and the southerly line of the proposed Dawson Street, containing 375 square feet.

Also all that part of lot 6, block 2 Smithson Land Company's Addition, lying between the

northerly line of block 2 of Smithson Land Company's Addition and the southerly line of the proposed Dawson Street, containing 375 square feet.

Also all that part of lot 5 block 2 of Smithson Land Company's Addition lying between the northerly line of block 2 Smithson Land Company's Addition and the southerly line of the proposed Dawson Street containing 375 square feet.

Also all that part of lot 4, block 2 Smithson Land Company's Addition, lying between the northerly line of block 2 of Smithson Land Company's Addition and the southerly line of the proposed Dawson Street, containing 375 square feet.

Also all that part of lot 3, block 2 Smithson Land Company's Addition, lying between the northerly line of block 2 of Smithson Land Company's Addition and the southerly line of the proposed Dawson Street, containing 375 square feet.

Also all that part of lot 2, block 2 Smithson Land Company's Addition, lying between the northerly line of block 2 of Smithson Land Company's Addition and the southerly line of the proposed Dawson Street, containing 375 square feet.

Also all that part of lot 1, block 2 Smithson Land Company's Addition, lying between the northerly line of block 2 of Smithson Land Company's Addition and the southerly line of the proposed Dawson Street, containing 375 square feet.

Also all that part of lot 1, block 1, Smithson Land Company's Addition, lying between the northerly line of block 1 Smithson Land Company's Addition, and the southerly line of the proposed Dawson Street, containing 421 square feet.
