

Ordinance No. 201157

An Ordinance accepting permits for rights of way for
the construction of certain sewers.

The City of Portland does ordain as follows:

Section 1. That the permit for right of way for the construction of the Ralph Road division of the sewer system in Greenway through, under and along the following described property, be and is hereby accepted by the City of Portland:

A strip of land 2 feet in width, the center line of which is described as follows: Commencing at the northwest corner of lot 3, in block "F", of the "Map of Greenway in Sections 4, 5, 8 and 9, Township 1 South, Range 1 East, Willamette Meridian"; and running thence south 47° 0' east, a distance of 44 feet, more or less, to an intersection with a certain pipe sewer heretofore constructed; thence along the line of said pipe-sewer north 82° 10' east, a distance of 401 feet, more or less, to an intersection with the westerly line of Mountain boulevard.

Section 2. That permits for rights of way for the construction of the Hancock Street Addition sewer system through, under and along the following described property, be and are hereby accepted by the City of Portland:

A strip of land 4-feet in width running east and west through Section 25, Township 1 North, Range 1 East, Willamette Meridian, the center line of which is described as follows: Commencing on the east line of East Thirty-third street at a point which is 30 feet east and 1,325 feet north of the quarter-section-corner located on the south side of said Section 25; and running thence north 89° 40' east to an intersection with the westerly line of said grantor's land, said point of intersection, which is 330 feet easterly, measured along the last above mentioned course from the northerly extension of the center line of East Thirty-fifth street, being the beginning point of the center line to be described; running thence north 89° 40' east from the said point of intersection and parallel to the northerly line of said grantor's land a distance of 50 feet, more or less, to the easterly line of said grantor's land.

A strip of land 4 feet in width running east and west through Section 25, Township 1 North, Range 1 East, Willamette Meridian, the center line of which is described as follows: Commencing on the east line of East Thirty-third street at a point which is 30 feet east and 1,323 feet north of the quarter-section corner located on the south side of said Section 25; and running thence north 89°40' east to an intersection with the westerly line of said grantor's land, said point of intersection, which is 380 feet easterly, measured along the last above mentioned course, from the northerly extension of the center line of East Thirty-fifth street, being the beginning point of the center line to be described; running thence north 89°40' east from the said point of intersection and parallel to the northerly line of said grantor's land a distance of 50 feet, more or less, to the easterly line of said grantor's land.

A strip of land 4 feet in width running east and west through Section 25, Township 1 North, Range 1 East, Willamette Meridian, the center line of which is described as follows: Commencing on the east line of East Thirty-third street at a point which is 30 feet east and 1,323 feet north of the quarter-section corner located on the south side of said Section 25; and running thence north 89°40' east to an intersection with the westerly line of said grantor's land, said point of intersection, which is 430 feet easterly, measured at right angles, from the northerly extension of the center line of East Thirty-fifth street, being the beginning point of the center line to be described; running thence north 89°40' east from the said point of intersection and parallel to the northerly line of said grantor's land a distance of 50 feet, more or less, to the easterly line of said grantor's land.

A strip of land 4 feet in width running east and west through Section 25, Township 1 North, Range 1 East, Willamette Meridian, the center line of which is described as follows: Commencing on the east line of East Thirty-third street at a point which is 30 feet east and 1,323 feet north of the quarter-section corner located on the south side of said Section 25; and running thence north 89°40' east to an intersection with the westerly line of said grantor's land, said point of intersection, which is 460 feet easterly, measured at right angles, from the northerly extension of the center line of East Thirty-fifth street, being the beginning point of the center line to be described; running thence north 89°40' east from the said point of intersection and parallel to the northerly line of said grantor's land a distance of 65 feet, more or less, to the easterly line of said grantor's land.

A strip of land 4 feet in width running east and west through Section 25, Township 1 North, Range 1 East, Willamette Meridian, the center line of which is described as follows: Commencing on the east line of East Thirty-third street at a point which is 30 feet east and 1,323 feet north of the quarter-section corner located on the south side of said Section 25; and running thence north 89°40' east to an intersection with the westerly line of said grantor's land, said point of intersection, which is 545 feet easterly, measured at right angles from the northerly extension of the center line of East Thirty-fifth street, being the beginning point of the center line to be described; running thence north 89°40' east from the said point of intersection and parallel to the northerly line of said grantor's land a distance of 65 feet to a point.

A strip of land 5 feet in width, the center line of which is described as follows: Commencing on the north line of Tillamook street at a point which is intersected by the northerly extension of the center line of East Thirty-fifth street, said point being 50 feet north and 30 feet west of the northwest corner of block 4, in Hancock Street Addition to City of Portland, situated in Section 25, Township 1 North, Range 1 East, Willamette Meridian; and thence running northerly following said extension of the center line of East Thirty-fifth street, a distance of 80.07 feet to the north line of said grantor's land.

A strip of land 4 feet in width running east and west through Section 25, Township 1 North, Range 1 East, Willamette Meridian, the center line of which is described as follows: Commencing on the east line of East Thirty-third street at a point which is 30 feet east and 1,323 feet north of the quarter-section corner located on the south side of said Section 25; and running thence north 89°40' east to an intersection with the westerly line of said grantor's land, said point of intersection, which is 280 feet easterly, measured along the last above-mentioned course, from the northerly extension of the center line of East Thirty-fifth street, being the beginning point of the center line to be described; running thence north 89°40' east from the said point of intersection and parallel to the northerly line of said grantor's land, a distance of 60 feet, more or less, to the easterly line of said grantor's land.

A strip of land 4 feet in width running east and west through Section 25, Township 1 North, Range 1 East, Willamette Meridian, the center line of which is described as follows: Commencing on the east line of East Thirty-third street at a point which is 30 feet east and 1,323 feet north of the quarter-section corner located on the south side of said Section 25; and running thence north 89°40' east to an intersection with the westerly line of said grantor's land, said point of intersection, which is 30 feet easterly, measured along the last above mentioned course, from the northerly extension of the center line of East Thirty-fifth street, being the beginning point of the center line to be described; running thence north 89°40' east from the said point of intersection and parallel to the northerly line of said grantor's land a distance of 50 feet, more or less, to the easterly line of said grantor's land.

A strip of land 4 feet in width running from east to west and from north to south through Section 25, Township 1 North, Range 1 East, Willamette Meridian, the center line of which is described as follows: Commencing on the east line of East Thirty-third street at a point which is 30 feet east and 1,323 feet north of the quarter-section corner located on the south side of said Section 25; and running thence north 89°40' east to an intersection with the easterly line of said grantor's land, said point of intersection, which is 30 feet easterly, measured at right angles, from the northerly extension of the center line of East Thirty-fifth street, being the beginning point of the center line to be described; running thence south 89°40' west from the said point of intersection and parallel to the northerly line of said grantor's land a distance of 50 feet, more or less, to an intersection with the said northerly extension of the center line of East Thirty-fifth street; thence southerly along the said northerly extension of the center line of East Thirty-fifth street, a distance of 9 feet, more or less, to a point on the southerly line of said grantor's land, which is 60.07 feet north of the north line of Tillamook street.

A strip of land 4 feet in width running east and west through Section 25, Township 1 North, Range 1 East, Willamette Meridian, the center line of which is described as follows: Commencing on the east line of East Thirty-third street at a point which is 30 feet east and 1,323 feet north of the quarter-section corner located on the south side of said Section 25; and running thence north 89°40' east to an intersection with the westerly line of said grantor's land, said point of intersection, which is 230 feet easterly, measured along the last above mentioned course, from the northerly extension of the center line of East Thirty-fifth street, being the beginning point of the center line to be described; running thence north 89°40' east from the said point of intersection and parallel to the northerly line of said grantor's land, a distance of 50 feet, more or less, to the easterly line of said grantor's land.

A strip of land 4 feet in width running east and west through Section 25, Township 1 North, Range 1 East, Willamette Meridian, the center line of which is described as follows: Commencing on the east line of East Thirty-third street at a point which is 30 feet east and 1,323 feet north of the quarter-section corner located on the south side of said Section 25; and running thence north $89^{\circ}40'$ east to an intersection with the westerly line of said grantor's land, said point of intersection, which is 130 feet easterly, measured along the last above mentioned course, from the northerly extension of the center line of East Thirty-fifth street, being the beginning point of the center line to be described; running thence north $89^{\circ}40'$ east from the said point of intersection and parallel to the northerly line of said grantor's land a distance of 100 feet, more or less, to the easterly line of said grantor's land.

A strip of land 4 feet in width running east and west through Section 25, Township 1 North, Range 1 East, Willamette Meridian, the center line of which is described as follows: Commencing on the east line of East Thirty-third street at a point which is 30 feet east and 1,323 feet north of the quarter section corner located on the south side of said Section 25; and running thence north $89^{\circ}40'$ east to an intersection with the westerly line of said grantor's land, said point of intersection, which is 80 feet easterly, measured along the last above mentioned course, from the northerly extension of the center line of East Thirty-fifth street, being the beginning point of the center line to be described; running thence north $89^{\circ}40'$ east from the said point of intersection and parallel to the northerly line of said grantor's land a distance of 50 feet, more or less, to the easterly line of said grantor's land.

Section 3. That the Auditor be and is hereby directed to have the permits for rights of way through the property described in Sections 1 and 2 of this ordinance placed on record.
