

Ordinance No. 29150

An Ordinance providing for changing the names of certain streets in the City of Portland.

The City of Portland does ordain as follows:

Section 1: That the names of streets within the newly annexed district heretofore known as "Lents" and more particularly described as follows:

The south 633 feet of Section 9, Tp. 1 S. R. 2 E, W.M., all of Section 16, Tp. 1 S. R. 2 E. W.M., and the north $\frac{1}{2}$ of Section 21, Tp. 1 S., R 2 E. W.M., and not included in Ordinance Number $\frac{\sqrt{9/5/}}{}$, be and the same are hereby changed or named as provided in Section 5 of this ordinance.

Section 2: All streets whose names are changed by this ordinance are understood and declared, unless otherwise stated, to have been laid out and named while without the corporate limits of the City of Portland, and the said streets are now within the said corporate limits.

Section 3: The suffix "S.E." meaning "southeast", is understood to be added to and made a part of each new street and avenue name or number.

Section 4: The tabular headings in Section 5 of this Ordinance are hereby made a part of and understood to fully describe and designate the name changes enumerated under them.

Section 5: That the following streets as given in the first column, located as described in the second column, shall be changed and hereafter known by the respective or corresponding names as given in the third column:

Section 6: Nothing contained in this ordinance shall in any way affect the validity of any proceedings now pending for the improvement, opening, laying-out, extending or widening of any of the streets above mentioned, or for the changing or establishing of grades thereon, but such proceedings shall continue and be completed as though the names of such streets had not been changed.

Section 7: It is the intent and purpose of this ordinance that each street in the district as described in Section 1 of this ordinance, be given one name throughout its entire length.
