TO THE COUNCIL:

On March 18, 2015, Council approved Ordinance #187051 for Procurement Services to competitively solicit the Rose Quarter Planter Box Project in accordance with PCC 5.34. The Chief Procurement Officer has advertised and received bids for Bid Number 00000011 (formerly 117829) on behalf of the Office of Management and Finance (OMF) with a project construction estimate of \$466,200.00. OMF rated the project estimate confidence level as Medium.

Bids were opened on April 28, 2015, and one (1) bid was received. The low bid of Lovett Inc. was responsive to the solicitation requirements, thus it is recommended that Lovett's base bid and add alternate be accepted at the lump sums quoted in their bid for a total amount of \$753,073.08.

OMF along with Procurement Services identified nine (9) Divisions of Work as potential subcontracting opportunities for this project resulting in \$124,855.00 awarded to subcontractors.

have a current City of Portland Business Tax Registration and EEO Certification, and are in Full Compliance with the Equal Benefits Program.

Funds are available in the FY 15-16 Spectator Facilities Program Budget, WBS Element MFOP00034.

It is recommended that a Performance Bond and Payment Bond each in the amount of 100% of the contract amount be furnished by the Contractor. Further, it is also recommended that a two (2) year Maintenance/Warranty Bond for 20% of the final contract amount be furnished by the Contractor before final payment is released.

The bid sureties of the remaining bidders should be returned immediately in compliance with Section 5.34.410D of the City Code.
