An Ordinance adopting the City Engineer's report made pursuant to Resolution No. 16396 for the proposed widening and extension of Corbett Street, from Woods Street to Hooker Street; the opening of a new street from the intersection of Corbett Street and Hooker Street to the intersection of Front Street and Arthur Street; the widening of Front Street from Arthur Street to Sheridan Street; the widening of Arthur Street from Front Street to Second Street; the opening and extension of Kelly Street from Grover Street to Porter Street; the widening of Grover Street, from Hood Street to Kelly Street; the widening of Kelly Street from Grover Street to Gibbs Street; and, the widening of Woods Street, from Corbett Street to First Street, in the City of Portland, Oregon.

The City of Portland does ordain as follows:

Section 1. The City Engineer's report filed with the City Auditor June 7, 1926, pursuant to Resolution No. 16396 for the proposed widening and extension of Corbett Street, from Woods Street to Hooker Street; the opening of a new street from the intersection of Corbett Street and Hooker Street to the intersection of Front Street and Arthur Street; the widening of Front Street from Arthur Street to Sheridan Street; the widening of Arthur Street from Front Street to Second Street; the opening and extension of Kelly Street from Grover Street to Porter Street; the widening of Grover Street from Hood Street to Kelly Street; the widening of Kelly Street from Grover Street to Gibbs Street; and the widening of Woods Street from Corbett Street to First Street, in the City of Portland, Oregon, is hereby adopted, approved and confirmed, which report is in words and figures as follows:

TO THE HONORABLE MAYOR AND COUNCIL

Gentlemen:

In the matter of the proposed widening and extension of Corbett Street, from Woods Street to Hooker Street; the opening of a new street from the intersection of Corbett Street and Hooker Street to the intersection of Front Street and Arthur Street; the widening of Front Street from Arthur Street to Sheridan Street; the widening of Arthur Street from Front Street to Second Street; the opening and extension of Kelly Street from Grover Street to Porter Street; the widening of Grover Street, from Hood Street to Kelly Street; the widening of Kelly Street from Grover Street to Gibbs Street; and, the widening of Woods Street, from Corbett Street to First Street, in the City of Portland, Multnomah County, State of Oregon, I hereby, pursuant to Resolution No. 16396 adopted by the Council June 2, 1926, make my report setting out herein the amount of damages and benefits which in my judgment should be awarded the owner of each lot, tract or parcel of land, or portion thereof, to be appropriated by said widening and extension, and a detailed assessment of each lot and parcel of land specially benefited according to its proportionate share of benefits resulting from such widening and extension; such assessment of benefits being for 25 per cent. of the total damages awarded for said widening, together with 25 per cent. of the total charge for engineering, surveying, appraisals, and other expenses, as provided in Section 559 of the Charter of the City of Portland, Oregon, all being as follows:

DESCRIPTION OF PROPERTY REQUIRED

A full description of such proposed widening and extension is as follows:

The widening of Corbett Street, from the north line of Woods Street to the north line of Hooker Street, and also an additional triangular parcel of land at the northwesterly corner of the intersection of Corbett Street and Grover Street, by appropriating the following described parcels of land.

Beginning at the southwest corner of block 44, Garth's Addition to Garth's Addition; thence westerly along the south line of block 44, 10 feet to a point; thence northeasterly along a straight line 100.46 feet to a point on the south line of lot 8, Block 44, said point being 0.5 foot west of the southeast corner of said lot 8; thence northerly along a line parallel to the east line of block 44 a distance of 100 feet to a point on the north line of Block 44; thence easterly along the north line of block 44, a distance of 0.5 feet to the northeast corner of block 44; thence northerly along the east line of block 44 a distance of 200 feet to place of beginning; and, also the westerly 40.0 feet of lots 10, 11 and 12, Block 50, Garth's Addition to Garth's Addition; and also, beginning at the southwest corner of Block 51, Garth's Addition to Garth's Addition, and running thence northerly along the east line of Corbett Street 220.24 feet to a point; thence southeasterly along a curve to the right having a radius of 235.15 feet a distance of 125.89 feet to a point which is 50.0 feet east of the east line of Corbett Street when measured at right angles thereto; thence southerly parallel to

said east line of Corbett Street 100.01 feet to a point in the south line of said block 81; thence westerly along said south line 50.0 feet to the place of beginning, and also

Beginning at the northeast corner of lot 1, block 45, - Garuthers Addition to Garuthers Addition; thence southerly along the east line of lots 1 and 2, 100 feet to the southeast corner of lot 2; thence northeasterly 107.50 feet along a curve to the left, having a radius of 166.15 feet to a point on the north line of lot 1, block 45, said point being 53.46 feet west of the northeast corner of lot 1; thence along the north line of lot 1, a distance of 52.42 feet to place of beginning, and also beginning at the southeast corner of block 105, South Portland Real Estate Association's Addition to Garuther's Addition running thence westerly along the south line of said block 105 a distance of 50.0 feet to a point; thence northeasterly 51.50 feet to a point on the east line of said Block 105; thence southerly to the place of beginning.

The opening of a new street, 90 feet in width, from the intersection of Corbett Street and Mockler Street to the intersection of Front Street and Arthur Street, including an additional widening 25 feet in width at the northeast corner of block 47, Garuther's Addition to Garuther's Addition, by appropriating the following described parcels of land, to-wit:

Beginning at the southeast corner of Block 48, Garuthers Addition to Garuthers Addition and running thence westerly along the south line of said block 90.31 feet to against; thence northeasterly 171.90 feet to a point in the west line of said block; thence northerly along said west line 70.77 feet to the northwest corner of said block; thence easterly 51.77 feet along the north line of said Block; thence southeasterly 209.95 feet to a point in the north line of lot 4, said block 48; which point is 15.29 feet

west of the northeast corner of said lot; thence easterly 15.89 feet to the northeast corner of said lot; thence southerly along the east line of said lot 59.0 feet to the point of beginning, and also;

Beginning at the southeast corner of Block 48,

Guthers Addition to Garth's Addition; thence westerly along the south line of said block 72.99 feet to a point; thence northwesterly 196.75 feet to a point in the west line of said block 48; thence northerly along the west line of said block 58.08 feet to the northwest corner thereof; thence easterly along the north line of said block 48 a distance of 59.00 feet to a point; thence southeasterly 294.22 feet to a point in the east line of said block; thence southerly along said east line 56.11 feet to the place of beginning, and also;

Beginning at the southwest corner of Block 49, Guthers Addition to Gaythers Addition; thence northerly along the west line of said Block 10.55 feet to a point; thence southeasterly 14.75 feet to a point in the south line of said block 49; thence westerly along said south line 10.74 feet to place of beginning, and also

Beginning at the northeast corner of Block 47, Guthers Addition to Garth's Addition; thence southerly along the east line of said Block 50.25 feet to a point; thence northwesterly 70.55 feet to a point in the north line of said block 47; thence easterly along said north line 49.25 feet to the place of beginning.

The widening of Front Street from 43.5 feet in width to a width of 50 feet, from the north line of Arthur Street to the south line of Sheridan Street, by appropriating 16.1 feet from

the westerly side thereof.

The widening of Arthur Street from 60 feet in width to a width of 80 feet, from the west line of Front street to the east line of Second Street, by appropriating 20 feet from the northerly side thereof.

The opening and extension of Kelly Street, from the north line of Grover Street to the south line of Porter Street, by appropriating the easterly 110.0 feet of the westerly half of block 90, Garuther's Addition to Garuther's Addition.

The widening of Grover Street, from the west line of Hood Street to the east line of Kelly Street, by appropriating a triangular parcel of land at the northeasterly corner of the intersection of Grover Street and Kelly Street described as follows:

Beginning at the southwest corner of block 103, South Portland Real Estate Association's Addition to Garuthers Addition; thence northerly along the west line of block 103, a distance of 70 feet to a point; thence southeasterly along a straight line a distance of 122.07 feet to the southeast corner of lot 5, block 103; thence westerly along the south line of said lot 5 a distance of 100 feet to place of beginning.

The widening of Kelly Street, from the south line of Grover Street to the north line of Gibbs Street by appropriating a parcel of land in block 116, South Portland Real Estate Association's Addition to Garuthers Addition, described as follows:

Beginning at the southeast corner of block 116; thence westerly along the south line of block 116 a distance of 11.54

feet; thence northwesterly a distance of 220.60 feet to a point on the north line of said block 116, said point being 95.84 feet easterly from the northwest corner of block 116; thence easterly along the north line of block 116, a distance of 104.66 feet to the northeast corner of block 116; thence southerly along the east line of block 116, a distance of 200 feet to place of beginning.

The widening of Woods Street to a width of 60 feet, from the west line of Corbett Street to the east line of First Street, by appropriating those portions of blocks 105, 106 and 107.

South Portland Real Estate Association's to Caruther's Addition,
lying between the south line of Woods Street, and a line drawn parallel to and 60.0 feet distant southerly from the north line of Woods Street including a triangular parcel at the southwesterly corner of the intersection of Woods Street and Corbett Street described as follows:

Beginning at a point on the east line of block 105, which point is 10.97 feet southwesterly from the northeast corner of block 105; thence south westerly along the east line of said block 105 a distance of 60 feet to a point; thence northwesterly a distance of 45.77 feet to a point, which is 60 feet northeasterly from the north line of Woods Street, when measured at right angles thereto; thence easterly parallel to the north line of Woods Street 40 feet to the place of beginning, in Multnomah County, State of Oregon.

of Arthur Street 16.1 feet to a point on the west line of Front Street, said point being 220.5 feet north of the southeast corner of said block 52; thence southerly along said west line of Front Street 220.5 feet to said southeast corner of block 52; thence west along the north line of Arthur Street 215 feet to the place of beginning; containing 7488 square feet.

The foregoing parcel is a part of a tract herein designated as Tract No. 4, and described as follows:

All of block 52, and a strip of land 20.5 feet wide, lying north of and adjoining said block 52, Garuthers Addition to Garuthers Addition; containing 46,966 square feet.

Beginning at a point on the west line of Front Street, 220.5 feet south of the northeast corner of block 51, Garuthers Addition to Garuthers Addition; thence westerly, parallel to the north line of Arthur Street 16.1 feet to a point; thence northerly, parallel to the west line of Front Street 220.5 feet to a point on the north line of block 51; thence easterly 16.1 feet to the northeast corner of said block 51; thence southerly along the west line of Front Street 220.5 feet to the place of beginning; containing 3550 square feet.

All of block 51, and a strip of land 20.5 feet wide, lying south of and adjoining said block 51, Garuthers Addition to Garuthers Addition; containing 46,966 square feet.

Garuthers Addition to Garuthers Addition; thence northerly along the east line of Front Street 10.55 feet to a point; thence southwesterly 14.73 feet to a point on the north line of Arthur Street, said point being 10.74 feet easterly from the southwest corner of lot 5; thence westerly along the north line of Arthur Street 10.74 feet to the place of beginning; containing 56 square feet.

The foregoing parcel is a part of a tract herein designated as Tract No. 6, and described as follows:

Beginning at the northwest corner of lot 8, block 48, Garuthers Addition to Garuthers Addition; thence easterly along the south line of Arthur Street 69.00 feet to a point; thence southwesterly 61.33 feet to a point on the west line of the east 100 feet of lot 1, block 48, said point being 43.81 feet south of the northwest corner of said east 100 feet of lot 1; thence south 56.19 feet to the southwest corner of the east 100 feet of lot 2, block 48; thence west 70.95 feet to a point on the south line of lot 7, block 48, said point being 41.05 feet east of the southwest corner of said lot 7; thence northwesterly 58.67 feet to a point on the west line of lot 7, said point being 8.09 feet south of the northwest corner of said lot 7; thence north 58.09 feet to the place of beginning; containing 9400 square feet.

The foregoing parcel is a part of a tract of land herein designated as Tract No. 7, and described as follows:

All of lots 7 and 8, and the west 6 feet of lots 1
