

## ORDINANCE No. 132325

An Ordinance amending Ordinance No. 132243 which vacated certain portions of S.W. 10th, S.W. 11th Avenues, S.W. Montgomery, S.W. Hall and S.W. College Streets, so as to include that portion of S.W. College Street inadvertently omitted from the description of the streets vacated, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that by Ordinance No. 132243, passed by the Council February 24, 1971, certain streets in the Portland State University area were vacated in connection with the urban renewal project; that in setting forth the description of the streets to be vacated, a portion of S.W. College at S.W. 10th Avenue was omitted, and said ordinance should be amended to include the area of that portion of S.W. College Street lying between the east line of S.W. 10th Avenue and a point 50 feet east of the east line of S.W. 10th Avenue; now, therefore, Ordinance No. 132243, passed by the Council February 24, 1971, hereby is amended to include the following additional description:

That portion of S.W. College Street lying between the east line of S.W. 10th Avenue and a point 50 feet east of the east line of S.W. 10th Avenue.

Section 2. This ordinance shall be an effective amendment to Ordinance No. 132243, upon acceptance by the Portland Development Commission, and all other terms and conditions of Ordinance No. 132243 shall remain in full force and effect.

Section 3. The Auditor shall file of record in the appropriate file of Multnomah County, and with the Assessor and Surveyor of said County, a certified copy of this ordinance and the acceptance thereof, all at the expense of the City.


Section 4. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that there may be no delay in correcting the original ordinance so that vacated streets may be effective without delay; therefore, an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
