ORDINANCE No. 128848

An Ordinance designating and assigning certain portions of unassigned City owned property, for the opening of S.E. Market Street, east of S.E. 92nd Avenue and declaring an emergency.

The City of Portland ordains as follows:

Section 1. It appearing to the Council that the parcel of land herein described constitutes a portion of Lot 7, Block 1, Rochester, owned by the City of Portland in fee simple without restrictions; that the parcel of land herein described should be designated as public street to be used in connection with the opening of S.E. Market Street east of S.E. 92nd Avenue and such will contribute to the public convenience in that the use of said property will provide street access for undeveloped property; now, therefore, the following described parcel of City-owned land is hereby designated and assigned for street purposes:

The south 60.0 feet of the north 83.66 feet of Lot 17, Block 1, Rochester.

Section 2. That the Auditor be and he is hereby directed to have a copy of this ordinance placed on record in Multnomah County.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: That the use of said property for street purposes is needed without delay; therefore, an emergency is hereby declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
