Subject: Reappointment of Jessica Engeman to the Historic Landmarks Commission

1) Reappointment & Historic Landmarks Commissioner candidate rationale.

I am recommending Jessica Engeman be reappointed to the Historic Landmarks Commission. Her 2nd term will be from October 2, 2015 to expire on October 1, 2019. This reappointment is in the "historian" category. Jessica is willing to serve the Commission again in a second term. Jessica has proven herself as a valuable member of the Commission given her current roll as Vice Chair, active participation, and insight into preservation and restoration matters, as well as, her diverse professional experience working with state and government-owned properties, as well as, private development proposals.

2) Upcoming Vacancies.

The Historic Landmarks Commission has two members whose 2nd terms will expire soon – one in October and one in December 2015.

This past August, we posted a Media Advisory announcing the openings for the Commission. Our mailing list included ONI for distribution to their Citywide notification list, which included LGBTQ community organizations, senior organizations, disability organizations, low-income organizations, and professional organizations. BDS Senior Planner Tim Heron, HLC Chair Brian Emerick and BDS Supervising Planner Kara Fioravanti reviewed a number of candidate applications that are under consideration.

With the proposed reappointment of Jessica Engeman, the Bureau of Development Services will continue its outreach efforts to fill upcoming vacancies on the Historic Landmarks Commission.
