We **ARE** talking about:

- A pilot project PBOT does not have ANY process for allowing community groups to build new trails
- How to build NEW trails
- A way to transfer liability and maintenance responsibility of existing, unpermitted trails

We **ARE NOT** talking about:

- Encroachment policies
- Funding non-profits to maintain trails
- A specific trail

how did we get here?

Southwest Urban Trails Plan (2000) –

"Residents and adjacent property owners need to be notified about the proposed improvements and should be supportive. Opposition to the improvements could require a more formal public process requiring City staff participation (pg 21)."

ORS 105.668 (2011) -

Immunity from liability for injury or property damage arising from use of trail or structures in public easement or right of way

public outreach

November 2014. Draft Trails Process released

November 2014 – February 2015. First comment period (targeted outreach, PAC, SWNI, SW News, SWTrails = 3,000+ website views, 175 comments)


March 2015. Staff incorporated comments

April 2015. Released updated draft (8,000+ mailers, NCs, previous commenters, targeted groups = 4,800+ website views, 150 comments)


Summer 2015. Council date delay due to requests from SWNI and SWTrails.

Total: ~20,000 website views, 300+ comments



Trail Type B – Hiking (moderate challenge)



Moderate challenge hiking trails may include steps and obstacles such as rocks and roots. They are located where some segments with slopes as steep as 8% are needed to avoid multiple switchbacks, tree removal or slope destabilization. Although less difficult than the high challenge hiking trails, they also require higher physical exertion and increase the diversity of trail experience.

USERS

The moderate challenge hiking trail requires good balance and moderate fitness. Single-file walking and (sometimes) running are desired uses. Moderate challenge trails are accessible to users who can navigate steeper slopes although there may be barriers such as steps, rocks or roots. Signs (Detail 12) or steps may be used at entry points to signal less accessible trail ahead.

MATERIALS

Native soil and rock are most common although steps, railings, and boardwalks are used as needed. [See Technical Provisions table page 8 for landings and passing area.]

Width	18" - 30"
Surface	Soil / stairs
Longitudinal Slope	0 - 8%
Cross-Slope	2% min 4% max.
Radius	NA - switchbacks
Sight Distance	Limited, consider safety needs
Easement Width	Tread + 10' min.
Side Slope	Varies
Vertical Clearance	8'
Horizontal Clearance	2' from side of tread





Can I help maintain the ROW?

Members of the public that are not adjacent property owners may not conduct maint on a ROW without the permission of the City or adjacent property owners. We recome any permission from the adjacent property owner is in writing. You can use the Communitated Neighborhood Trails Process (portlandoregon.gov/transportation/trails) to a for maintenance permission from the City.

Can I build anything in the ROW?

Members of the public may not construct anything in the ROW without the proper pe permissions from the City. You can use the Community-Initiated Neighborhood Trails (portlandoregon.gov/transportation/trails) to apply for permission and the proper bu permits from the City.

I don't think the adjacent property owners are maintaining the ROW ne their home properly or blocking access. What can I do?

If you believe an adjacent property owner is not properly maintaining the ROW adjact their property, please contact the Bureau of Development Services (BOS) at 503.823.6 will then assess the right-of-way's "current and necessary use" (per Chapter 29.20.01 Code) and notify the adjacent property owner of their responsibility.



While on a (st)roll through your neighborhood, you find yourself on an unimproved PBOT right of way. If you—or a community group—are interested in making this an official trail, answer the following:

Get neighbors involved

Activity support is an effort to promote the presence of responsible pedestrian users in a given area. What you can do:

- Encourage immediate neighbors to walk the trail on a regular basis.
- Start a Foot Patrol trained by the City of Portland's Crime Prevention Program.
 Neighbors volunteer to walk in a small group along the trail, be a friendly presence and report problems, where necessary.
- Call the police when you see suspicious activity. Call 9-1-1 for immediate threats to life or property or a crime in progress. Otherwise, contact the police nonemergency number at 503-823-3333.

Maintain the trail

The strategies that you employ above are only as good as your commitment to maintain them. Steps you can take.

- Repair burned out lights, trim vegetation regularly, and pick up litter and debris.
- Eliminate trip hazards along the path whether that includes uneven surfaces, rocks, or ruts along the path.
- Work with PBOT to see if a dog bag dispenser and garbage receptacle can be installed to discourage waste being left on the path.
- Report all graffit. If it's on your property, take a picture, report it and remove it immediately. See www.portlandoregon.
