

ORDINANCE No. 187 468

* Authorize a grant agreement with Portland Opportunities Industrialization Center Inc., not to exceed amount of \$103,842 for two street level gang outreach workers, to provide intervention services while principally deployed for service within City of Portland, Bureau of Parks and Recreation facilities and properties (Ordinance)

The City of Portland ordains:

Section 1: The Council finds:

1. The City, through the Office of Youth Violence Prevention (OYVP), manages and oversees the Street Level Gang Outreach Grant Program, established in 2009. The program is modeled after a nationally recognized best practice acknowledged by the Office of Justice Programs, U.S. Department of Justice, and Bureau of Justice Assistance (BJA).
2. The City in 2015, through the Mayor's Community Centers Initiative, provided grant funding to be made available for 2 new Street Level Gang Outreach worker positions, the services of which will be principally applied and made available to youth and adults using park Portland Parks and Recreation (PP&R) community centers, facilities and properties.
3. Portland Opportunities Industrialization Center Inc. (POIC), a local private non-profit youth service organization, due to service excellence and expertise exhibited previously through the Street Level Gang Outreach Grant Program, was selected under the Community Center Initiative to receive grant funding to employ 2 Street Level Gang Outreach workers,
4. The amount of this grant is not to exceed \$103,842.00
5. The grant agreement will be for a period of 1 year, from December 1, 2015 to November 30, 2016.

NOW, THEREFORE, the Council directs:

- a. The City of Portland designates and authorizes the expenditure of grant funds for the purpose described in Section 1. The Commissioner for the Bureau of Parks and Recreation, Designee or the Grant Manager, are authorized, on behalf of the City, to execute a grant agreement not to exceed \$103,842.00.
- b. The funds associated with this grant agreement will come from funding made available to the Bureau of Parks and Recreation through the Mayor's Community Center Initiative in 2015.
- c. The Director of the Bureau of Parks and Recreation is authorized to execute amendments to the scope of services or the terms and conditions of this Agreement and to renew this Agreement, subsequent to fiscal year 2015-2016 provided sufficient funds are appropriated by City Council, included within the City's approved budget and changes do not increase the amount of compensation or increase the City's financial risk.


