## Ordinance No. 75242

An Ordinance accepting certain property for the opening of North Gatton Avenue, in the City of Portland, and declaring an emergency.

The City of Fortlend does ordain as follows:

Section 1. That the following described deeds be and are hereby accepted by the City of Portland for street purposes:

Section 2. That the City Ruditor be and he is hereby directed to have the deeds for street purposes as described in Section 1 of this ordinance placed on record and a copy of said ordinance forwarded to the County Assessor.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: It is necessary that this street be opened as a public thoroughfare at the earliest possible date; therefore, an emergency is hereby declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
