Ordinance No. __80202

An ordinance granting a disability allowage of Fifty Dollars per month to Bans G. Greeville, on employe of the Sureau of Mater Works, authori ing the drawing of variants and declaring an emergency.

The City of Portland does ordsin as follows:

Section 1. The Council finds that Hons G. Oranville has been an employe of the Eureau of Nater Norks for over twenty-three years, that he is now seventy years of age and unable to perform his duties as a laborer in the Bureau of Water Works, which fact is certified by the City Physician, therefore there is hereby granted to Hans G. Granville, 826 M. Smerson Street, a disability allo ance of Fifty Pollars per month from and after August Sth. 1944. Buch Mischlity allowance shall continue for such length of time as may be determined by the Council, subject to the provisions of Ordinance No. 77760, as amended by Ordinance No. 79750, and provided that this dismullity allowance is granted upon the xpress condition that seid Hans C. Granville shall file with the Auditor and the Municipal Civil Dervice Board a written relinquishment of all rights he may have under the Civil Service provisions of the Charter.

Section 2. That the Mayor and Auditor are hereby authorized to draw and deliver surpants in the pursuance of the provisions of Section 1 of this ordinance, chargeable to the appropriation heretofore made out of the Water Fund for the payment of Sundry Charges 5700/610.

Section 3. Inasmuch as this ordinance is necessary for the imbediate preservation of the public health, peace and enfety of the City of Portland in this: In order that and Hans G. Granville may receive the disability allocance authorized herein, and without delay, it is necessary that this ordinance become effective intedistely; therefore an emergency is hereby declared to exist and this ordinance shall be in force and effect from and ofter its passage by the Council.
