

ORDINANCE NO. 82364

An Ordinance providing for the acquisition of rights of way for sewer lines, pumping sites and other rights for the Sewage Disposal Project; and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. It appearing to the Council that the Sewage Disposal Project for this City has advanced to a point that rights of way, pumping sites and other rights should be acquired for said project; now, therefore, the Commissioner of Public Works through the City Engineer is hereby authorized on behalf of the City to acquire such rights of way for conduits and property for pumping sites and other rights as are needed for carrying said project to completion in accordance with the plans as they have been heretofore prepared or as they may be modified and completed from time to time, it being understood and provided that the acquisition of easements, rights and pumping sites shall be obtained by agreement with the owners of property where an agreement can be reached on reasonable terms but otherwise by condemnation proceedings to be taken in accordance with the Charter provisions concerning the acquisition of property for street extension and/or widening. Provided, that no property shall be obtained by agreement without Council approval and provision for payment. All such costs whether by agreement or condemnation shall be paid from the Sewage Disposal Fund. Property for pumping sites shall be acquired in fee simple in cases where a full title is needed therefor.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: The City must be prepared to take prompt action in said matters; therefore, an emergency is hereby declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
