

**ORDINANCE No.** 187623

\*Amend contract with Cascade Centers, Inc. for employee assistance services through June 30, 2021 (Ordinance; amend Contract No. 30002042)

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Human Resources, Health & Financial Benefits Office requires the continuing provision of employee health and welfare administration as provided under PCC Section 5.33.220.
2. In order to maintain the employee assistance program services it is deemed appropriate and necessary to amend the contract as attached in the following Exhibit A
  - a. This contract shall expire, unless otherwise terminated or extended, on June 30, 2021
  - b. Additional compensation is required under this contract for the extended five year period. The new contract not-to-exceed amount will be increased by \$1,500,000 to \$2,709,600.00

The Health Operating Fund has sufficient appropriation in support of the benefit and the contract listed above


NOW THEREFORE, the Council directs:

- a. The Mayor or the Director of Human Resources is hereby authorized to execute the contract amendment and any subsequent renewals during the term of the contracts, hereto as Exhibit A attached
- b. The Mayor and the Auditor are hereby authorized to draw and deliver warrants not to exceed the amounts listed in each independent contract.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in providing benefits to plan participants; therefore, this ordinance shall be in full force and effect from and after its passage by Council.
