An Ordinance designating and assigning as street a portion of Lot 2, Block "A", Greenway, for the extension and widening of S.W. Greenway Avenue, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. It appearing to the Council that certain property as hereinafter described, has been acquired by the City of Fortland for the extension of S.W. Greenway Avenue in connection with the widening and improvement of S.W. Talbot Read and S.W. Greenway Avenue, in the City of Fortland, but this parcel of land has not been officially designated and assigned street area, and the Council being of the opinion that such designation and assignment should be made without delay, now, therefore, the following described parcel of land is hereby designated and assigned to the use aforesaid.

Said parcel of land to be used for the purposes herein mentioned is more particularly described as follows:

A portion of Lot 2, Block "A", Groenway, more particularly described as follows:

Beginning at a point in east line of Lot 6, Block "L", Amended map of Blocks "J" to "P", Greenway, 37.2 feet S. 0° 13' W. of the southeast corner of Lot 5, said Block "L"; thence 3. 0° 13' W. a distance of 20.47 feet to a point in the westerly line of the Portland Railway Company's right-of-way; thence northeasterly along said Portland Railway Company's right-of-way to a point in the east line of said Lot 2, Block "A", Greenway; thence W. 0° 13' E. along said east line of Lot 2, Block "A", Greenway, a distance of 4.6 feet to a point; thence on a curve left having a radius of 538.0 feet (the long chord of which bears 5. 37° 13' W. 124.62 feet) a distance of 124.9 feet to the place of beginning.

Section 2. That the City Auditor be and he is hereby directed to have a certified copy of this ordinance placed on record and a copy of said ordinance forwarded to the County Assessor.

Section 3. Inestaich as this ordinance is necessary for the immediate preservation of the public health,
