ORDINANCE No. 90766

An Ordinance designating and assigning as street area that portion of Lot 10, lying north of alley, Eleck "K", Amended Map of Blocks "J" to "P", Greenway, now owned by the City of Portland, and declaring an emergency.

The City of Portland does ordain as follows:

Soction 1. It appearing to the Council that certain property, as hereinafter described, has been acquired by the City of Portland in connection with the extension and improvement of S.W. Greenway Avenue, in the City of Portland, but this parcel of property has not as yet been officially designated and assigned street area, and the Council being of the opinion that such designation and assignment should be made without delay; now, therefore, the following described parcel is hereby designated and assigned to the use aforesaid. Said parcel of land to be used for the purposes herein montioned is more particularly described as follows:

All that portion of Lot 18, lying north of alloy, Block "K", Amended Map of Blocks "J" to "P", Greenway, in the corporate limits of the City of Portland, County of Multhomah and State of Oregon.

Section 2. That the City Auditor be and he is hereby directed to have a certified copy of this ordinance placed on record and a copy of said ordinance forwarded to the County Assessor.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: The use of said property for street purposes is needed without delay; therefore, an emergency is hereby declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
