ORDINANCE No. 93229

An Ordinance designating and assigning as street a portion of Lots 1 and 2, Block 31, Love's Addition, now owned by the City of Portland, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. It appearing to the Council that certain property, as hereinafter described, has been acquired by the City of Portland (Sewage Disposal Fund); that the parcel of land herein described is required for the widening of N.E. Columbia Blvd. and such will not be a detriment to the Sewage Disposal System and will contribute to the public convenience in the use of said property by providing better street access; now, therefore, the following described parcel of property is hereby designated and assigned to the use aforesaid. Said parcel of property to be used for the purposes herein mentioned is more particularly described as follows:

That portion of Lot 1 and the west one-half of Lot 2, Block S1, Love's Addition, lying northerly of a line 50.0 feet southerly of and parallel to the center line of N.E. Columbia Blvd. (formerly County hoad No. 97), in the corporate limits of the City of Portland, County of Bultnomah and State of Oregon.

Section 2. That the City Auditor be and he is hereby directed to have a certified copy of this ordinance placed on record and a copy of said ordinance forwarded to the County Assessor.

Section 3. Inamuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: The use of said property for street purposes is needed without delay; therefore, an emergency is hereby declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
