ORDINANCE No. 50000

An Ordinance declaring certain streets previously used for sawmill purposes open to the public, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. The Council finds that the Supreme Court of the State of Oregon in the case of City of Portland v. Inman Poulsen Lumber Co., in 1913, reported at 66 Or. 86, decreed that the City could not restrain obstruction of certain streets as dedicated by plat during the continuance of occupancy of said area for sawmill purposes due to previous acts of city officials: that said area involved in said court determination has been occupied for sawmill purposes to the present time; that now the Inman-Poulsen Lumber Co. has notified the City that it is no longer using the streets lying east of S.E. Grand Avenue for sawmill purposes; that therefore said streets should be declared open; now, therefore, the following streets are declared open to the public use: S.E. Sherman Street and S.E. Caruthers Street, as originally platted, extending from the east line of S.E. Grand Avenue as now established to the southwesterly line of the Southern Pacific Company's railroad right-of-way; S. E. 6th Avenue and S. E. 7th Avenue, as criginally platted, extending from the northerly line of S.E. Division Place to the southwesterly line of the Southern Pacific railroad right-of-way, excepting however that part of S.E. 6th Avenue vacated by Ordinances No. 98565 and 98566, passed by the Council of the City of Portland June 10, 1953.

Section 2. The Auditor hereby is authorized and directed to file for record, a certified copy of this ordinance, in the appropriate records in the Office of the County Clerk of Multanomah County, Oregon.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace, and safety of the City of Portland in this: In order that there may be no delay in restoring to public use street area as dedicated now that conditions prohibiting such opening under court order have been eliminated; therefore an emergency
