

## ORDINANCE No. 100289

An Ordinance making a transfer of appropriation in the sum of \$200.00 from the General Fund Appropriation, Bureau of Police, Headquarters Division, Operation and Maintenance, to the General Fund Appropriation, Bureau of Police, Police Reserves and Sunshine Division; authorizing the drawing of warrants, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. The Council finds that the operating costs for the Bureau of Police, Police Reserves and Sunshine Division, are running heavier than anticipated in the 1953-54 budget, and that the appropriation heretofore made out of the General Fund is exhausted and that it has been anticipated to cost an additional \$200.00 for the Operation and Maintenance of the Police Reserves and Sunshine Division for the remainder of the current fiscal year; now, therefore, the sum of \$200.00 be and the same is hereby transferred from the General Fund Appropriation, Bureau of Police, Headquarters Division, Operation and Maintenance, Code No. 332, to the General Fund Appropriation, Bureau of Police, Police Reserves and Sunshine Division, Operation and Maintenance, Code No. 348; that the Mayor and Auditor be and they hereby are authorized to draw warrants on said appropriation when demands therefor have been presented approved by the proper authority.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: That it is necessary to provide additional appropriation for the Operation and Maintenance of the Police Reserves and Sunshine Division without delay; therefore, an emergency is hereby declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
