ORDINANCE No. 100960

An Ordinance granting an additional leave of absence, without pay, for six months, to Theodore A. Bowers, Bureau of Water Works, on account of illness, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. The Council finds that Theodore A. Bowers, Water Bureau employe, has filed a request, under oath, for a leave of absence, without pay, for a period of six months beginning August 1, 1954; that said Theodore A. Bowers was granted an original leave of absence from February 1, 1954, to July 31, 1954, by Ordinance No. 99966, passed by the Council on February 17, 1954; that his request for additional leave is supported by the statement of Thomas L. Meador, City Health Officer, and that said request has been approved by Nathan A. Boody, Commissioner of Public Utilities, and by M. A. Mosely, Superintendent, Construction and Maintenance, and Ben S. Morrow, Engineer and General Manager, Bureau of Water Works; now, therefore, a leave of absence, without pay, hereby is granted to Theodore A. Bowers, Bureau of Water Works, for six months beginning August 1, 1954, and ending January 31, 1955, inclusive.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland, in this: In order that necessary arrangements may be made, therefore, an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
